

Stakes for pop-up shelters should not exceed 8" to prevent damage to the sprinkler system Please respect the Purina Grounds with your compliance to these rules.

\*Rabies and Vaccination Certificate- Missouri requires proof of current Rabies Vaccination carried with you. Tags are not accepted.
