IWSCA NATIONAL SPECIALTY CHALLENGE TROPHIES

The winner will have custody of the Challenge Trophy until one month prior to the next National Specialty and shall engrave the name and title(s) of the winning dog thereon, before returning it to the Specialty Trophy Chairman. For permanent possession, each Challenge Trophy is to be won three times by the same owner, not necessarily with the same dog, nor at consecutive National Specialty shows.

Best of Breed Competition

Non-Regular (Additional) Classes Involving Single Dog Entries

The following non-regular classes will be provided for both dogs and bitches
Winners of the following classes are eligible to compete in Best of Breed Competition if
undefeated in any other class at this show.

Veteran (7 yrs & Under 9 yrs) Veteran (9 yrs & over)

Neutered Dogs and Spayed Bitches are eligible to enter Veteran classes

Gun Dog Class - For Dogs and Bitches that have an AKC Hunting title and/or an IWSCA Working Certificate and/or Working Certificate Excellent and/or an AKC Field Trial Title. Neutered Dogs and Spayed Bitches are eligible to enter the Gun Dog classes.

Non-Regular (Additional) Classes Involving Multiple Dog Entries

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won these classes.

Stud Dog Class – For Stud Dogs and at least two, and not more than four of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered in one of the Regular Classes or, if a Champion of Record, in Best of Breed competition, but must be entered in the Stud Dog class. The Get must be entered in one of the Regular Classes or, if a Champion of Record, in Best of Breed competition.

The Stud Dog shall be considered one entry and requires one entry fee – this being the regular fee plus the additional class fee, if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the dog show rules, AKC policy, or the standard of the breed.

Brood Bitch Class - same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

Stud Dogs and Brood Bitches may be spayed or neutered.

Awards of Merit

The Irish Water Spaniel Club of America offers Awards of Merit at its National Specialty Show in recognition of the quality dogs that are in serious contention for the top breed awards. It excludes the Best of Breed winner and the Best of Opposite Sex winner that by virtue of their placements have already been recognized. It is entirely the judge's decision whether to give all of the Awards of Merit, only some, or none. The number of awards that may be made is determined by the size of the entry based on the # of dogs competing in the Best of Breed ring including entered Champions of record, any move-ups, Veteran Dogs, Veteran Bitches, Winners Dog and Winners Bitch x 10% rounded up, with no consideration as to sex. JUNIOR SHOWMANSHIP COMPETITION

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have won three (3) first place awards, with competition present, in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

Classes offered: Fetch Novice & Fetch Intermediate

AKC Fetch is a pass-fail noncompetitive test. The four levels of titles (Novice, Intermediate, Advanced, and Retriever) assess the ability of the dog to retrieve. In the Advanced and Retriever levels, the dog must respond correctly to signals. There is also a memory component in Advanced and Retriever because a retrieving bumper or ball is dropped (or thrown) behind a blind where it cannot be seen.

For each of the four titles, the dog must pass the test twice under two different approved AKC Fetch judges.

Dogs who are at least 6 months of age are eligible to take the AKC Fetch test as long as they are registered or enrolled with AKC and have an AKC, PAL, or AKC Canine Partners number.

ATTENTION EXHIBITORS

Trophies must be picked up on the day of the show. The IWSCA will not assume responsibility for mailing trophies not claimed the day of the show. All unclaimed trophies become the property of the IWSCA.

Cash prizes will be distributed to the person handling the dog, paid in the ring. Claims for prize money must be made in the ring before judging of the next class. The Superintendent/Show Secretary and Club disclaim liability for cash prizes once the prize has been awarded in the ring.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for the first entry and \$3.50 for each additional entry at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.
