Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

The Batesville, MS Fire Marshal has specific requirements for the use of extension cords as follows:

Exhibitors are required to provide their own extension cords.

Extension cords shall be a UL listed assembly (with tag) rated for the load connected:

- 1: Dryers plus equipment totaling 1500 watts or less require a UL Listed extension cord assembly rated for 15 amps.
- 2: Dryers plus equipment totaling more than 1500 watts require a UL Listed extension cord assembly rated 20 amps.

Each extension cord assembly shall terminate with a Ground Fault Circuit Interrupter (GFCI) device for personnel protection.

Spot inspections will be conducted by the Batesville Fire Department for compliance with these requirements.

Non-compliance with these requirements could result in a citation from the Fire Department.

Description of event: Magnolia Classic Brush Hunt is a ratting event like Barn Hunt but without the straw/hay and rule restrictions. It provides the dog an opportunity to scent a rat cage/tube in a safe, fun, positive setting, an extra sensory experience; a fantastic way to evaluate your dog for his/her ratting/scenting ability.

Any size dog may participate.

It is non-sanctioned by AKC.

The area is designed with multiple woody brush piles, all natural materials in a fenced-in area.

Start Time: **8:30 am – 5:00 pm**, Saturday and Sunday.

Participants are encouraged to sign-up/pay in advance; if a ring conflict, they may return to run their dog on the day of payment, **prior to 5:00 pm**.

Rules : The handler and dog enter the start box, the time starts when the owner releases the dog into the fenced, brush area. After one minute, the handler may assist the dog in locating the rat; the Judge will also encourage the dog to locate and engage the rat. The Judge determines the official time when the dog locates the rat no greater than 2 minutes. Also, the Judge calls the time of the “find”.

NO RATS ARE HARMED, they are hand-raised, loved, and considered personal pets who have been trained in the event.

Ribbons will be awarded for the fastest time (1st-4th) in both the Novice and Advanced classes Saturday and Sunday.

Costs:

Novice - \$10 per dog, rat is in a wired cage and hidden in the brush.

Advanced - \$10 per dog, 1 rat in tube and hidden in the brush.

The participant may repeat runs at the above cost.

So, can your dog find the rat and become the Best of the Best in Brush Hunt?

Dog Days of Summer Cluster Rules

- No outside food or beverages may be brought into the Batesville Civic Center building, except items for babies. Of course, bait, food and water for dogs are permitted.
- No smoking in the building, covered arenas, dog bathing area.
- Leave flashers on while loading or unloading. No parking is allowed in the loading and unloading areas. **10 minute unloading strictly enforced. Exhibitors small dogs and/ or small amounts of loading equipment are encouraged to use the ramps at the East and West entrances (front and back of the civic center). Proceed from the entrances to the elevator at the southwest corner to go to the lower level for reserved grooming.**
- All RV's, self-contained units and box trucks must park in the designated RV parking areas in the South Parking lot only.
- RV Parking Lots are reserved parking areas in the south parking lot only. Only those reserving overnight spaces or assigned to day-parking by the camping committee are permitted to park there.

The show grounds for RV parking will NOT be available until after **9:00 AM on Wednesday**. If you are arriving in the Batesville area prior to this date, you are directed to go to John Kyle State Campground, 27550 MS-315, Sardis, MS 38666, 662-563-4936.

- Building will be available on **Wednesday at 2:00 PM**. For safety reason no one, except for club members, vendors and Cluster staff, is permitted to bring equipment or dogs into the building until setup is complete
- No saving of space for others is permitted. The Event committee will monitor excessive use of space in order to provide a good experience for all exhibitors.
- Building will be open at **6:00 AM** prior to the events and will be locked at **10:00 PM** on Wednesday through Saturday nights.
- Grooming is permitted only in designated areas. Observe all aisles as marked and keep them clear.
- Mats or tarps are not allowed on the concrete in crating areas, except a stress-relief mat at each grooming table.
- For the convenience of exhibitors, crates and tables are allowed close to the conformation rings in designated staging areas 15 minutes before and after scheduled ring times and during the judging or for photographs.
- Dogs may be left in the building overnight on Wednesday, Thursday, Friday, and Saturday nights. All owners or handlers leaving dogs overnight in the building **MUST** leave a clearly visible card with emergency cell-phone contact information near the crated dogs. A guard will patrol the building and the RV parking lots throughout the night. However, the Cluster members assume **NO** liability for any animals or equipment left in the building overnight.
- Any dog displaying signs of illness (e.g., excessive coughing) will not be allowed in the building.
- Exhibitors are expected to observe all posted signs and to clean up after their dogs both inside and outside the building. Bags are available inside at the Trophy Table for solid waste. Plenty of trash cans and waste buckets are distributed throughout the site. Please immediately notify a member of the Event Committee or a member of the Custodial Crew, if liquids need mopping.
- Exhibitors are responsible for maintaining clean conditions in and around their setups.
- No private exercise pens in the building or in the North Parking Lot.
- Shavings or other comparable materials used in private exercise pens in the parking lots must be swept up, bagged and deposited in a dumpster prior to the individual's leaving the show. NO shavings or other comparable material may be placed on grass or dirt.
- Dogs must be removed from the building by **6:00 PM** on **Sunday** night.
- See additional rules and notices under **ATTENTION EXHIBITORS and Special Instructions**.

Dogs may not be left unattended in vehicles, unless the vehicle is specially-equipped with adequate air-conditioning (e.g., motorhomes and recreation vehicles).

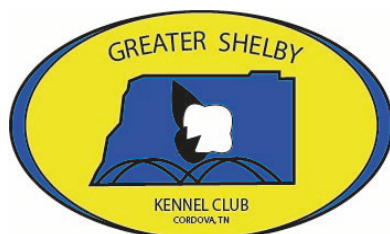

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5 to under 9 years of age at all shows offering Pee Wee. Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- At an All-Breed event, all AKC fully recognized and Miscellaneous Class breeds are allowed to enter, including dogs with a PAL listing.
- In addition to an entry, a release must be signed by the child's parent or legal guardian. Release forms will be available at the show.

At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience - no Junior will be "judged" but rather will be mentored with the age appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation **Rosette** and each dog will receive a squeaky toy to commemorate the experience!

The Judge should explain the process of showing the dog to the Junior and the responsible adult in the ring including breed specific presentation. Depending on the size of the dog and the child, the adult may be asked to lift a table breed on or off the table, or the Club may mandate that the adult should do it regardless. Neither the youngster nor the adult should be asked to show the bite.
