The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

DON'T FORGET TO CHECK THE OWNER-HANDLED BOX ON THE ENTRY FORM

All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

^{*}Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

Consult Judging Program for meeting place & time

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5 to under 9 years of age at all shows offering Pee Wee.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- At an All-Breed event, all AKC fully recognized and Miscellaneous Class breeds are allowed to enter, including dogs with a PAL listing.
- In addition to an entry, a release must be signed by the child's parent or legal guardian. Release forms will be available at the show.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience—no Junior will be "judged" but rather will be mentored with the age appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation Rosette and each dog will receive a squeaky toy to commemorate the experience!

The Judge should explain the process of showing the dog to the Junior and the responsible adult in the ring including breed specific presentation. Depending on the size of the dog and the child, the adult may be asked to lift a table breed on or off the table, or the Club may mandate that the adult should do it regardless. Neither the youngster nor the adult should be asked to show the bite.

Competition is offered for dogs & bitches entered and exhibited in the Bred-by-Exhibitor Puppy Class & Bred-by-Exhibitor Adult Class to compete for Best of Breed Bred-By-Exhibitor through Best Bred-By-Exhibitor in Show. Dogs that win Best of Breed or Best of Winners in the regular conformation classes are automatically Best of Breed Bred-By-Exhibitor. AKC offers a FREE Litter Registration for Best Bred-by-Exhibitor in Show.

VETERANS - BOTH DAYS BREED • GROUP • BEST IN SHOW

There will be Puppy, Bred By Exhibitor, & Open Classes for each of the Miscellaneous Breeds in each sex.

Puppy and Bred-By classes will be divided by age if all-breed classes are divided.

Winners from these classes will compete for Best of Breed & Best of Opposite Sex to Best of Breed in each breed. Each Miscellaneous Best of Breed winner shall be eligible to compete for Best in Miscellaneous Class. All entries for Best in Miscellaneous Class shall be made after judging of the individual Miscellaneous breed classes. In the event that the owner of a dog designated Best of Breed shall not exhibit the dog in the Best of Miscellaneous Class Competition, no other dog of the same breed shall be allowed to compete. There shall be no further competition for dogs entered in the Miscellaneous Class. Ribbons shall conform to Chapter 5, Section 2 of AKC Rules.

AKC Sanctioned 4 - 6 Months Puppy Competition

This is a recorded event by the AKC for the Certificate of Merit and Puppy of Achievement certificates. Section 1 - Classifications The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over, but under six months on the first day of the event. Classes will be offered for breed and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs

Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs

Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

USF OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Retrievers (Nova Scotia Duck Tolling, Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendeen, Whippet, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Australian Cattle Dog, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, Basset Fauve de Bretagne (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers, Pulik.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Lagotto Romagnolo, Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terrier, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

No radios or TVs are to be playing in the building. If anyone wants to listen to music or videos, headphones must be used.


The Parking Lot will be available to RVs at 12:00 noon on Friday. Early arrivals, appointments must be made - contact Marian at (704) 473-1747.

The Show Building will be available to vendors at 10:00 am & to exhibitors at 12:00 pm on Friday. Dogs are to be removed from the show site following Best in Show judging on Sunday.

- No smoking is allowed inside the arena building. No alcoholic beverages are allowed on show grounds or in parking areas.
- Exhibitor parking will be designated. There will be a designated area outside the building for loading & unloading of dogs & equipment. Signs will be posted. Dogs &/or equipment are not allowed through the main lobby glass doors (benchable offense).
