USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, Retrievers (Nova Scotia Duck Tolling, Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendéen, Whippet, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Australian Cattle Dog, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, Basset Fauve de Bretagne (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers, Pulik.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terrier, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. **Please Check www.AKC.org for updates to this list. (1/31/2024)**

No solicitations are permitted in the RV area, to include products, signage, or other sales communications or activities. Contact the Vendor Chair and reserve a vendor space in the building if desired. Parking will be on a compacted gravel/dirt lot adjacent to the Roberts Centre.

There will be no saving of spaces. Only one (1) extra vehicle will be allowed per site, other than the vehicle used to tow a trailer. Any vehicle blocking Fire Lanes or entrances/exits of buildings will be towed at the owner's/exhibitor's expense. **No dumping of gray or black water allowed anywhere on site.**

Roberts Centre will charge \$50.00 for RV spots not cleaned. Please put trash in dumpster.

I understand that this reservation will be accepted on a first-come, first-served basis, and that I will accept the space I am assigned. I further understand that reserved parking is a privilege that can be withdrawn from those who do not follow the rules, regulations and instructions of the show giving club and Roberts Centre. I will not hold WCKC or its officers, directors, or members responsible for any loss of or damage to personal property or personal injury.

Attention Campers!!!

There will be a limited number of hook ups available for rent. Sites will have water, sewer hook up, and 30/50 amp service. Cost:
\$45 per night with hook ups
\$25 per night dry camping

Attention Exhibitors

- **PARKING:** There is ample free car parking available. There is also NO reserved parking. If you place cones or other objects to reserve parking spaces, they will be picked up and may be retrieved at the WCKC table for a \$25 fee.
- The Show Site will be available to exhibitors at 12:00 pm on Friday, March 29, 2024. Dogs must be removed from the Show Site immediately following Best in Show judging Sunday, March 31, 2024.
- **Royal Canin Ring** will be locked from 10 p.m. to 6 a.m. daily.
- **Dogs may not be left overnight. (violators will be subject to a disciplinary committee)**
- Grooming in designated areas only!
- **Day Grooming** - ALL items must be removed by end of Best in Show. Any items left in day grooming will be removed by host club and owners will be charged \$25 reserved grooming fee payable in cash prior to return of items.
- No gasoline or diesel generators permitted within 100 ft. of any building in which the show is conducted.
- Use of private exercise pens is not permitted inside the building and are strongly discouraged around the building perimeter.
- Inside crating in designated areas only. Crates should be stacked. No soft-sided crates permitted.
- **No crates permitted ring side except during judging only.**
- Dogs must be on leash except when crated or as required for judging.
- All trophies must be claimed the day of the show. None will be mailed. Trophies not claimed will become the property of the show-giving club. The Club reserves the right to substitute a trophy of equal or greater value.
- **All exhibitors must clean up after their dogs--outside, inside and in the ring! (violators will be subject to a disciplinary committee)**

NOTICE TO EXHIBITORS • ROYAL CANIN RING & HOTEL RULES

- 1.No exercise pens allowed in front of Royal Canin Ring or Hotel. Exercise pens around the perimeter of the entire building are strongly discouraged.
- 2.No exercise or potty pens permitted inside Royal Canin Ring .
- 3.No soft crates are permitted inside Royal Canin Ring .
- 4.No crates permitted ringside except during judging and shortly before and after.
- 5.Marked crating areas MUST be observed.
- 6.Crates should be stacked.
- 7.All dogs are required to be on-leash at Royal Canin Ring and Hotel at all times (except when crated or as required to be judged).
- 8.Children under 12 must be accompanied by an adult when on show grounds.

PUBLICATION RIGHTS: By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition. The Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in the premium list and assumes all risks involved.

NO PRACTICING ALLOWED IN RINGS AT ANY TIME. Dogs May Arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring. No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted. As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media. Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for the first entry and \$3.50 for each additional entry at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor the Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging.

Judges need not wait for any dog holding up the class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.

PUBLICATION RIGHTS By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.
