Test headquarters: Charlemont Reservation 48799 New London Eastern Road, Wellington, OH 44090. This location is the closest address to the headquarters. Our location is actually a gravel parking lot. You will notice the portapotty at the edge of the lot. You have arrived!

ROUTES TO THE TEST SITE

FROM SAWMILL CREEK LODGE: 37.1 miles=45 minutes per Google directions. Head south on Sawmill Creek Dr W towards US 6E. Turn left onto US 6E then turn right to stay on US 6E. Turn left to merge onto US 6E. Continue onto OH 2E for 6 miles. Take the OH-61 exit towards Berlin Heights then turn right onto OH 61 S for 4.3 miles. Continue straight onto Ceylon Rd for 1.4 miles. Continue onto Hartland Center Rd for 4.7 miles. Turn left onto OH 18E for 10.8 miles. Are you dizzy yet? Turn right onto OH 511 S for 6.8 miles then turn left onto New London Eastern Rd. (NOT New London-Lafayette Rd OR Rt 162) Go 1.5 miles and you have arrived (:The parking lot headquarters is on the right. You will see the tracking flags, portapotty and the other cars.

FROM THE OHIO TURNPIKE EAST OF EXIT 152: Go right from the toll-booth and follow the signs to Rt. 10 and Oberlin. Take Rt. 10 West and it will merge into Rt. 20 West. Follow Rt. 20 to the intersection with Rt. 58. Take Rt. 58 South through Wellington to New London-Eastern Rd. New London-Eastern Rd. is 7.8 miles past the McDonalds in Wellington. Turn right (west) and follow New London-Eastern Rd. to the test site, on the left between Baker Rd. and Quarry Rd.

FROM THE TURNPIKE WEST OF EXIT 91: Leave I-80 at Exit 91 to avoid Cedar Point traffic. Head South on Rt. 53 to Rt. 20. Take Rt. 20 East to Rt. 511. Follow Rt. 511 South (right) to New London-Eastern Rd. Turn East (left) to the test site between Baker Rd. and Quarry Rd.

FROM I-71 SOUTH: Take I-71 North past Ashland and exit at Rt. 301. Take Rt. 301 North to Rt. 224. Go west on Rt. 224 to Rt. 58. Go North on Rt. 58 to New London-Eastern Rd. Turn West (left) and follow it to the test site between Baker Rd. and Quarry Rd.

FROM I-480 EAST: Take I-480 West to Rt. 10. Follow Rt. 10 and it will merge into Rt. 20 West. Follow the remainder of directions under OHIO TURNPIKE EAST.

FROM I-90 EAST OR WEST: Take I-90 West/East, west of Cleveland to Rt. 58 South and exit. Follow remainder of directions in OHIO TURNPIKE EAST

FROM PA-OHIO TURNPIKE EAST: Follow I-76 West to State Rt. 224 West. Take St. Rt. 224 to St. Rt. 58. Go North on Rt. 58 to New London-Eastern Rd. Turn west (left) there and follow it to the test site, between Baker Rd. and Quarry Rd.

FROM THE HOTELS IN AMHERST: Follow Rt., 58 South through Wellington. See OHIO TURNPIKE EAST directions above.

FROM THE HOTEL IN ASHLAND: Go East on Rt. 250 to Rt. 89. Turn left (north) on Rt. 89 , cross over Rt. 42 and continue north. Rt. 89 runs into Rt. 58. Go North on Rt. 58. When you cross into Lorain County, New London-Eastern Rd is the next road. Turn left (west) and follow it to the test site on the left between Baker and Quarry Roads.

GOOGLE DIRECTIONS ADDRESS: 48799 New London Eastern Rd, Wellington, OH 44090. The closest numeric address we can guesstimate. The test headquarters is a parking lot. Look for the flags!

Certification: A written statement must accompany each TD entry for any dog that has not previously passed an American Kennel Club TD Tracking Test. The statement must be dated within one year of the date the test is to be held, signed by a person approved by the AKC to judge Tracking Tests, and must certify that the dog has satisfactorily performed a certification test.

Entry limitations: The Tracking Dog Test will be limited to 4 Dalmatians. The Tracking Dog Excellent Test will be limited to 4 Dalmatians. If the limit is not reached in Dalmatians, other breeds may enter using the following procedure: Draw (1) Dalmatians without a TD or TDX Title, Draw (2) Dalmatians with a TD or TDX Title, Draw (3) Other breeds without a TD or TDX Title, Draw (4) Other breeds with a TD or TDX Title. If the limit for entries is not reached in one test and the limit is exceeded in the other test, the number of tracks will be exchanged up to the limit set by the AKC Tracking Regulations.

Dogs must be six months of age or older.

Entries must be on an official AKC entry form & will not be accepted without fees & signature & a statement of certification, if applicable.

When the limit of 4 dogs for the TD test & 4 dogs for the TDX test have been drawn, all remaining entries, subject to the conditions set forth above, shall be assigned a position on the alternate list corresponding to the order in which they are drawn. The test secretary will notify all entries of the result within 24 hours after the draw. Please include your email address!

Drawing of Entries for TD/TDX Test: A drawing will be held at 7:00 pm on April 24, 2019 at the home of the Test Secretary. Should the limits not be reached for the TD or TDX test, tracks may be exchanged on a basis of two TD tracks equal one TDX track. The drawing shall be completely random among all Dalmatian entries received without a title followed by Dalmatians with a Title. Any remaining tracks will be filled by other breeds (including All Americans) without a title followed by other breeds (including All Americans) with a title in accordance with Chapter 1, Section 13, Option 2 of the Tracking Regulations. When the limits have been drawn for all Dalmatian TD and TDX entries, all remaining entries shall be assigned to a position on an alternate list corresponding to the order in which they were drawn. The Test Secretary will notify all entrants of the results of the draw by email within 24 hours after the draw. Upon notification, alternates shall have the option of accepting or refusing the opportunity to be placed on the alternate list.

Drawing for Tracks: The Judges will assemble the participants at the test site parking lot for a drawing by lot for the track number of each participant. The time for the draw will be stated in the Judging Program which will be emailed to the participants. The order in which tracks are run and the number of each track shall be determined by the Tracking Judges. Entrants & alternates must be present at this drawing to guarantee their position in the test. The first track for each event will be run as soon thereafter as it has aged the proper length of Time. In the event of absentees among the confirmed entries, the next alternate, in drawing order who is present, will be allowed to fill the vacancy.

Refunds: No entry fee will be refunded, except the entry fee of a non-participating alternate. Or in the event an accepted entry cancels after the closing date & the Secretary is able to replace the entry from the alternate list. The entry fees will be refunded within seven days following the Test.

Bitches in season: Tracking Regulations Chapter 2, Section 8. Bitches in season may participate. The Test Secretary & judges are to be notified prior to the drawing for running order the day of the test. The last track(s) to be laid shall be reserved for the bitch(es) in season. If there is more than one bitch in season, a second draw for these bitches will be held.

The show-giving club, the Test Secretary, the land-owners or Lorain County Metroparks assume no responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers or to any of their dogs or property, and further assumes no responsibility for injury to children.

No dogs allowed in rest rooms & no washing of animal food containers in rest rooms.

Exercise dogs in designated areas only. There will be a portapotty at the site. Very important!

No videotaping or photography during the events for resale is permitted without Dalmatian Club of America, Inc. approval.

Please be advised: When exhibitors/handlers bring a dog to the podium for a win/placement photo, they are establishing a de facto contract with the show photographer to purchase that photo.

All AKC Rules & Regulations will be enforced by the Show Event Committee under AKC guidelines. Failure to comply with these rules will result in charges being brought before the Show Event Committee. Any event hearing, disciplinary action, rule violations, complaints or charges will be resolved by the Dalmatian Club of America, Inc. National Specialty Event Committee. The Show Event Committee members are: Toni Linstedt, Chair, Dr. Charles Garvin, Kevin O'Connell, Paula Olcott, SarahAnne Vancleeve, Meg Hennessey and Linda Lombardi.

The show-giving club assumes no responsibility for the welfare of children & further expects exhibitors & spectators to keep their children under strict control.

Unless otherwise specified, all trophies must be claimed the day of the show. None will be mailed, except for those trophies that have been specified herein.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendents/Secretaries will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The Club reserves the right to substitute a prize of equal or greater value.

RETURNED CHECKS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. The Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis. Owners are responsible for errors in filling out entry forms; no refund for duplicate entries or errors on entry blanks.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Secretary.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, Additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

EXHIBITORS NOTE: Please notify Secretary of any change of address.

Telephone Entries and Unsigned Entries Cannot Be Accepted.

Entries Not On Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE. Acknowledgement of entries will be made as soon as practicable via email.

An AKC Recording Fee of \$3.50 cents will be required for each dog entered at any Licensed or Member Club Show or Agility Trial. These Fees are to be collected by the show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the test, the \$3.00 event service fee will be collected on Additional entries as well. (American Kennel Club Rule, Chapter 11, Section 2).

Dachshunds (longhaired, smooth, wirehaired), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard), Collies (rough, smooth).
2. The following categories of dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
