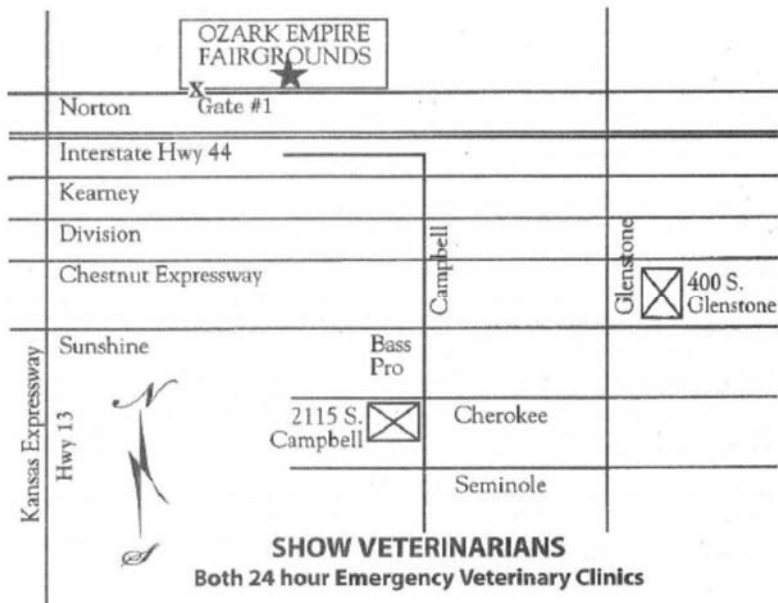

### **Premier Grooming Set Up is at 12 Noon on Wednesday, November 7, 2018**

Dogs must be removed from the show site immediately following Best in Show judging on Sunday, November 11, 2018. The building will be locked from 10:00pm to 6:00am, Wednesday through Saturday nights. A security person will be on duty each night during these hours as a courtesy to Exhibitors. Each dog that is left in the facility overnight must be identified with a tag stating the owner/agent name and where they can be reached in case of an emergency. In the event of multiple entries, one tag will be sufficient provided it clearly outlines the number of dogs & the area in which they are crated.
