Directions to Family Pet Health Care: Turn left on Horse Center Rd, turn right on Shoal Creek Rd, turn left on AL-67 N and go to the 5th stoplight. Turn left at that light onto Indian Hills Rd SE and the clinic is .02 miles on the right.

Directions to Huntsville Veterinary Specialists & Emergency: Turn left on Horse Center Rd, turn right on Shoal Creek Rd, turn left on AL-67N and go to I-65 N to the Huntsville exit 340 and take I-565 E. Go 17 miles and use the right 2 lanes to take exit 17B for AL-53 S toward Governors Drive. Go 2 miles on Governors Drive and turn left onto Dr. Joseph E. Lowery Blvd, the hospital will be on your right about 400 ft.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

The Cotton Cluster will provide 2 large Booster Baths
for bathing at the show site.

Routes To The Show

DIRECTIONS FROM I-65: Exit 334 Hwy 67, from the South turn right, from the North turn left and go under I-65. Then go 2.9 miles. Turn right on Shoal Creek Rd. Turn right on Horse Center Rd. The arena is on the right. There is a sign, Morgan County Celebration Arena.

We are happy to be having our shows but want to be sure that everyone is safe and stays safe!

Please be prepared to follow any Covid 19 restrictions enacted by the state, local, or the arena at the time of the shows. Check the Cotton Cluster FB page for information. The clubs reserve the right to adjust the protocols for this event.

An inherent risk of exposure to communicable diseases exist in any public place. Communicable diseases can be extremely contagious and/or leads to severe illness and death. Event attendees voluntarily assume all risk related to exposure to communicable disease. Attention Exhibitors

The 2021 Cotton Cluster is open to club members, exhibitors, and their guests, and will be open to the general public again. In view of the ongoing Covid pandemic, however, we ask anyone who is ill or feeling sick to please stay home. If you become ill at the show, we ask that you leave the show grounds.

The Show Site will be available to exhibitors at NOON, Wednesday. Dogs must be removed from the arena immediately following Best in Show judging of the Decatur Alabama Kennel Club, Inc. on Sunday.

Overnight parking is available. There will be hook-ups at a charge of \$35.00 per night. No hookups \$25.00 per night. Approximately 80 hook-ups, day parking fee \$5.00 per day or 4 day pass \$15.00.

PLEASE PICK UP AFTER YOUR DOGS & YOURSELF, SO WE CAN CONTINUE TO USE THESE SHOW GROUNDS.

Booth space will be available by invitation only.

All ringside crates must be removed immediately after showing and must be attended.

No crates, grooming, or private ex-pens will be allowed in the arena building except for a limited amount of space allocated for temporary ringside crating. Ringside crates must be attended and labeled with owner's name, cell number, and breed. Ringside crates can be brought into the arena just before judging of that breed and must be removed within 15 minutes after that breed judging is completed. Crates left beyond that time may be removed from the arena by the show committee. Ringside crating may be further restricted or even eliminated by the show committee, if necessary, to allow space for social distancing around the rings or if exhibitors fail to remove crates as stipulated.

Photographers providing services to the Cotton Cluster are independent contractors. It is the sole responsibility of the owner or owner's agent to inquire as to fees prior to obtaining a photo. All inquiries regarding photographers shall be directed to the photographer. Reminder: All photographs are copywritten.

All rights to televise, videotape, advertise, photograph, promote or otherwise exploit the event are vested in the show-giving club(s). All persons & animals on the show grounds at any time while the show is in progress do, by attending these shows, grant to the club(s) the right to photograph, televise, videotape, audiotape or otherwise use their likeness and voice in any manner without further release or consent. AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
