SPECIAL NOTICE TO EXHIBITORS

No banners or posters other than those in vendor spaces or those supporting the AKC, or the ESSFTA will be allowed at the show site (including the Hampton Inn grounds)

All Owners and Handlers are responsible for cleaning their grooming areas. The Show Event Committee shall take appropriate actions against anyone who disregards published club regulations. This may include holding a bench hearing in connection with the same.
