## Directions to Show

Route From Philadelphia International Airport (all roads have tolls, no matter the direction taken)  
Get on I-95 S from Exit 12B. Head southwest on Exit 12B. Keep right to stay on Exit 12B and follow signs for PA-291/Cargo City. Use the left lane to turn left onto PA-291 W/Bartram Ave.  
Turn left onto the I-95 S ramp and merge onto I-95 S. Use the right two lanes to take Exit 7 for I-476 N toward Plymouth Meeting Continue onto I-476 N (19.4 mi).  
Keep left at the fork to stay on I-476 N (Toll road 10.6 mi.). Keep left to stay on I-476 N (Toll road 27.1 mi.). Take Exit 56 for US-22 toward Lehigh Valley/I-78/PA-309/Allentown/Harrisburg (Toll road 0.6 mi). Keep right at the fork and merge onto US-22 E (2.4 mi.). Keep left to stay on US-22 East (8.6 mi). Take the PA-512 N Exit (0.3 mi). Continue on PA-512 North to Gateway Dr.

Coming from I-78 east or west, take PA 512 exit and go north and turn right on to Gateway Drive.  
Coming from I-81, take I-78 east and follow directions above.

### Hotel Fees/Deposits

The room rate is \$99.99 per night plus tax for a total cost of \$109.98. Damage waiver forms will be provided for completion at check-in. Additionally there is a \$20 per day and per dog fee for having more than two dogs in your room. For example, three dogs in your room will incur an additional \$20 for a total of \$119.99 plus tax per day, four dogs in your room will incur an additional \$40 for a total of \$139.99 plus tax per day, etc. for each room.

Guests have up until 72 hours prior to cancel their individual reservations. The room block is set up so that everyone calls and makes his/her own hotel reservation and deposit. The entire room block will be held until 4/2/2021 after which any rooms reserved in the block without a reservation will be released back into inventory.

### DOGS IN ROOMS PER SBCA RULE

Effective with the 2012 National Specialty, the SBCA established the following rules that attendees must follow in order to keep their dog(s) in guest rooms of the host hotel. "Guest room" definition includes, but is not limited to: rooms, condos, suites, or units, no matter how many bedrooms are involved. Only 2 dogs of any breed per room/condo/suite/unit. Dogs must be crated at all times while in a guest room. Appropriate measures must be taken to protect the carpet and surrounding areas under and near the crate. The guest agrees to take full financial liability for all damages by the pet including but not limited to: odor, damaging furniture or any part of the room, urination, etc. This includes other parts of the hotel where the dog may have to pass through to get to the rooms, i.e., the hallways and elevators. The room is to be inspected by a hotel associate and a designated member of the Show Committee before the deposit is credited or returned.

*IF YOU ARE CAUGHT NOT FOLLOWING THIS RULE YOU WILL HAVE A BENCH SHOW HEARING AND FINES*

**SBCA POOP FINE POLICY** Any person who does not pick up after their dog on any part of the show grounds and hotel site for the National including but not limited to the ring area, parking lots, grassy areas and event sites, shall be subject to a \$50.00 fine. This notice will be printed in the Premium List as well as posted on the Show's website. Further notices will be posted throughout the show site, including placing flyers in any hospitality bag or registration handouts. A full copy of this policy can be obtained from the Corresponding Secretary. The Show Committee, if necessary, will obtain a list of offenders of either of the above policies, and submit the list to the Board and the SBCA President will write a letter of reprimand to the offenders.

*IF YOU ARE CAUGHT NOT FOLLOWING THIS RULE YOU WILL HAVE A BENCH SHOW HEARING AND FINES*

Dogs found in an unsafe environment, distress, or in harm's way will be moved to safety. (Examples: Dogs left unattended on a grooming table, in a noose not attached to a safety release clip, or left in a vehicle without proper ventilation) Exposing a dog to an unsafe environment, distress, or putting it in harm's way is considered mistreatment.

# COVID RULES
