# COVID RULES

**PLEASE NOTE:** An inherent risk of exposure to communicable diseases exists in any public place. Communicable diseases can be extremely contagious and lead to illness or death. Event attendees voluntarily assume all risk related to exposure to COVID-19 and other communicable diseases related to humans and canines.

Due to the pandemic, the SBCA National will be following the COVID regulations set forth by the PA Department of a Public Health, CDC, AKC and local health department which are subject to change along with the OH Department of Public Health where the SBCA is incorporated.

Due to the constantly changing requirements, the most updated information related to rules will be posted in the Judging Program and on the Foy Trent website.

By entering these events, you have agreed to observe any and all COVID-19 health requirements that are in effect by the State of Pennsylvania, the Best Western Lehigh Valley Hotel and Conference Center, the American Kennel Club, The Saint Bernard Club of America, the CDC, and the county and city in which these events are held.

**All of the following practices MUST be followed:**

- It is a difficult time to put on any event, so please be respectful to judges, stewards, the show committee, and volunteers.
- Social distancing consistent with guidelines in effect at the time of the event must be followed.
- Masks will be required at all times while on the show grounds. A face shield alone is insufficient; it must be worn with a mask. (*Vented masks and gaters are not acceptable face coverings.*) **\*\* NO EXCEPTIONS! \*\***
- Consider wearing disposable gloves as needed and wash your hands frequently.
- Avoid shaking hands, hugging, or other physical contact.
- Avoid touching dogs that are not your responsibility.
- Be respectful of others around you. No congregating under the tent, around the rings, or in the grooming area is allowed. No seating will be provided. Bring your own chair.
- Exhibitors should know your number(s) before approaching the ring stewards for your armband(s).
- Anyone on the show grounds MUST follow these rules. Failure to do so can result in removal from the show grounds and/or a bench committee hearing.
- Everyone attending the show must sign a waiver that will be available with the premium list and judges program.

## **Hotel Fees/Deposits**

The room rate is \$99.99 per night plus tax for a total cost of \$109.98. Damage waiver forms will be provided for completion at check-in. Additionally there is a \$20 per day and per dog fee for having more than two dogs in your room. For example, three dogs in your room will incur an additional \$20 for a total of \$119.99 plus tax per day, four dogs in your room will incur an additional \$40 for a total of \$139.99 plus tax per day, etc. for each room.

Guests have up until 72 hours prior to cancel their individual reservations. The room block is set up so that everyone calls and makes his/her own hotel reservation and deposit. The entire room block will be held until 4/2/2021 after which any rooms reserved in the block without a reservation will be released back into inventory.

## **DOGS IN ROOMS PER SBCA RULE**

Effective with the 2012 National Specialty, the SBCA established the following rules that attendees must follow in order to keep their dog(s) in guest rooms of the host hotel. "Guest room" definition includes, but is not limited to: rooms, condos, suites, or units, no matter how many bedrooms are involved. Only 2 dogs of any breed per room/condo/suite/unit. Dogs must be crated at all times while in a guest room. Appropriate measures must be taken to protect the carpet and surrounding areas under and near the crate. The guest agrees to take full financial liability for all damages by the pet including but not limited to: odor, damaging furniture or any part of the room, urination, etc. This includes other parts of the hotel where the dog may have to pass through to get to the rooms, i.e., the hallways and elevators. The room is to be inspected by a hotel associate and a designated member of the Show Committee before the deposit is credited or returned.

*IF YOU ARE CAUGHT NOT FOLLOWING THIS RULE YOU WILL HAVE A BENCH SHOW HEARING AND FINES*

**SBCA POOP FINE POLICY** Any person who does not pick up after their dog on any part of the show grounds and hotel site for the National including but not limited to the ring area, parking lots, grassy areas and event sites, shall be subject to a \$50.00 fine. This notice will be printed in the Premium List as well as posted on the Show's website. Further notices will be posted throughout the show site, including placing flyers in any hospitality bag or registration handouts. A full copy of this policy can be obtained from the Corresponding Secretary. The Show Committee, if necessary, will obtain a list of offenders of either of the above policies, and submit the list to the Board and the SBCA President will write a letter of reprimand to the offenders.
