AED ON-SITE: The Hotel has two AED's (1) located at Hotel Front Desk (2) Located at The Spa Center

CRATING: Reserved Crating will be available for a fee as well as day crating at no charge. Please see the reservation form in the information packet available at https://www.vcaweb.org/events/specialty_2021.shtml for the reserved crating space. The reserved crating area will be available beginning Friday, October 15 @ 5pm. All crates must be removed at the conclusion of events Thursday, October 21. Dogs may **NOT** be left in the crating areas after posted show hours. **All Crates** must have an ID with cell phone number clearly marked. Soft crates are acceptable, however stacking is encouraged. Owners/handlers will be responsible for their dogs and will be asked to relocate them if they cause a nuisance by barking or disturbing other exhibitors. There will be NO security in the crating areas.

FOOD AND ENTERTAINMENT: Food will be available for purchase at the hotel's Swan Terrace Restaurant for lunch, dinner, or brunch. Cooked-to-order breakfasts are available daily from 6:30 AM to 10 AM for a fee. There will also be a Grab N Go open at select times for quick meals and beverages for breakfast and lunch.
