Directions to Family Pet Health Care: Turn left on Horse Center Rd, turn right on Shoal Creek Rd, turn left on AL-67 N and go to the 5th stoplight. Turn left at that light onto Indian Hills Rd SE and the clinic is .02 miles on the right.

Directions to Huntsville Veterinary Specialists & Emergency: Turn left on Horse Center Rd, turn right on Shoal Creek Rd, turn left on AL-67N and go to I-65 N to the Huntsville exit 340 and take I-565 E. Go 17 miles and use the right 2 lanes to take exit 17B for AL-53 S toward Governors Drive. Go 2 miles on Governors Drive and turn left onto Dr. Joseph E. Lowery Blvd, the hospital will be on your right about 400 ft.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
