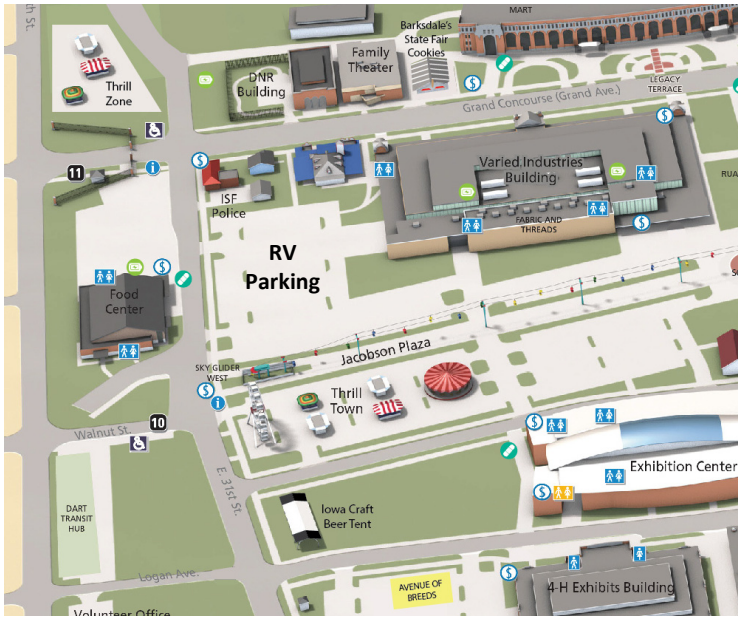
**From the West:** From I-235, take Exit 10A then head east on E University Avenue approximately four miles to the Fairgrounds.

## **ATTENTION EXHIBITORS**

CCKC COVID Mitigations will follow state and local guidelines at this show. Per CDC guidelines non-vaccinated individuals must wear a mask at all times. Mask are required for all other individuals in the building except when exhibiting in the ring unless requested by the judge or if CDC guidelines change.

All dogs must have current parvo shots & proof of rabies vaccination.

**Please:** We suggest no baby strollers in the building, for the safety of the children

No Flexi-leads or leads over 6 Ft in the building.

No dogs allowed in the restrooms. No grooming or bathing of dogs in the restrooms. No bathing of dogs in any of the fairground buildings.

Food service will be available in the Varied Industries Building

Please keep the show grounds & building clean. Exhibitors will be responsible for their own set-up areas.

**Exhibitors are expected to clean up after their dogs on show grounds at ALL times.**

AKC Rules Applying to Dogs Shows, Chapter 11, Section 11, states: Only dogs that are eligible to be shown under the American Kennel Club rules shall be allowed within the show precincts.

### **EMT will be present at Show Site Saturday & Sunday**

This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

**NEW EXHIBITOR BRIEFING** on Saturday, Check Judging Program for time & location.

The club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show—None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/ or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent is not able to cash checks.

The Southwest corner door of the Varied Industries Building will be opened first at 6:30 AM followed by all other doors. Grooming area will be available 5:30 PM to 7:30 PM on Friday and Saturday and Sunday after 6:30 AM. Dogs must be removed from the show site after Best in Show, Sunday. Doors will be locked from 10:00 PM to 6:30 AM.

Entry to Fairgrounds through Grand Avenue gate only.

**All vehicle parking is controlled by the fairground police.**

Parking on hard surface lot next to the building.

Grooming in designated area only. Obedience crating only around Obedience rings. Soft sided crates allowed for Obedience crating. This will be strictly enforced!!

**Reserved grooming available. Open grooming limited.**

Crates must be stacked. No private ex-pens, cocker pens, puppy pens, rugs or mats allowed in the building. Designated aisles must be kept open!

Toy crates may be stacked in designated area of center aisle only during the time that breed is being judged. **No soft-sided crates allowed.**

There will be no roping off or saving of grooming spaces inside the building or parking spaces outside building.

Motor home & box trucks check in at the Public Safety Office for assistance in parking.
