Routes To The Show

The Fairgrounds is on the East side of Lawrence

FROM THE EAST: K-10 to 23rd Street exit, then continue west on 23rd Street, turn right (north) on Harper to Fairgrounds.

FROM THE WEST: I-70 to LeCompton exit, turn right (south), take K-10 to Clinton Pkwy - go east. Clinton Pkwy will turn into 23rd St. Continue east on 23rd St. to Harper, turn left to Fairgrounds.

FROM THE NORTH: I-70 to East Lawrence exit, south to 6th street, turn west to Tennessee, go south to 19th Street, turn east (left) and drive to Harper, turn right to Fairgrounds.

FROM THE SOUTH: Take US 59 to 23rd Street, turn right (east), drive to Harper, turn left to Fairgrounds.
