# Routes To The Show

## *The Fairgrounds is on the East side of Lawrence*

**FROM THE EAST:** K-10 to 23rd Street exit, then continue west on 23rd Street, turn right (north) on Harper to Fairgrounds.

**FROM THE WEST:** I-70 to LeCompton exit, turn right (south), take K-10 to Clinton Pkwy - go east. Clinton Pkwy will turn into 23<sup>rd</sup> St. Continue east on 23<sup>rd</sup> St. to Harper, turn left to Fairgrounds.

**FROM THE NORTH:** I-70 to East Lawrence exit, south to 6<sup>th</sup> street, turn west to Tennessee, go south to 19<sup>th</sup> Street, turn east (left) and drive to Harper, turn right to Fairgrounds.

**FROM THE SOUTH:** Take US 59 to 23<sup>rd</sup> Street, turn right (east), drive to Harper, turn left to Fairgrounds.
