EXHIBITORS INFORMATION

The Show Site will be available to Exhibitors at noon, Thursday, November 3, 2022 (when rings are complete or earlier at the discretion of Show Chairperson). Exhibitors and Dogs must be removed from the show site by 9:00 pm on Sunday, November 6, 2022.

Dogs are not permitted in the rest rooms or food areas.

Dogs will not be allowed to remain overnight in the Stalls or Arena.

4-6 Month Beginner Puppy, All-Breed Sanction B Matches, Conformation Classes, CGC & Trick Dog Test, will be under cover in the Stock Arena.

Fast CAT events will be held outdoors.

Professional Handlers are allowed to enter dogs owned by them in Beginner Puppy; however, a non-professional handler must show the Puppy per AKC Rules for 4-6 Month Beginner Puppy.

Professional Handlers are allowed to enter B Matches **ONLY** if listed as Owner of Record of the dog exhibited. (Professional Handler is defined as any person who belongs/has belonged to a Professional Handlers Organization, distributed Rate Cards, advertised/represented themselves as a Handler for pay.)

Major pointed dogs **will be allowed** to enter the All-Breed Sanction B Match.

Reservation Payments may be made via PayPal at an additional charge of \$3.00.

Returned checks and/or declined credit/debit cards does not constitute a valid entry fee. Entries will be cancelled in the event of checks returned due to insufficient funds or declined credit/debit cards.

No entry fee will be refunded if the Show/Events cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, Act of Terrorism, COVID-19 restrictions, strikes or any other cause beyond the control of MCGKC and/or Harrison County Fairgrounds.

Exhibitors should follow their Veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

Exhibitors are responsible for cleanliness of your area and picking up after our dogs.
