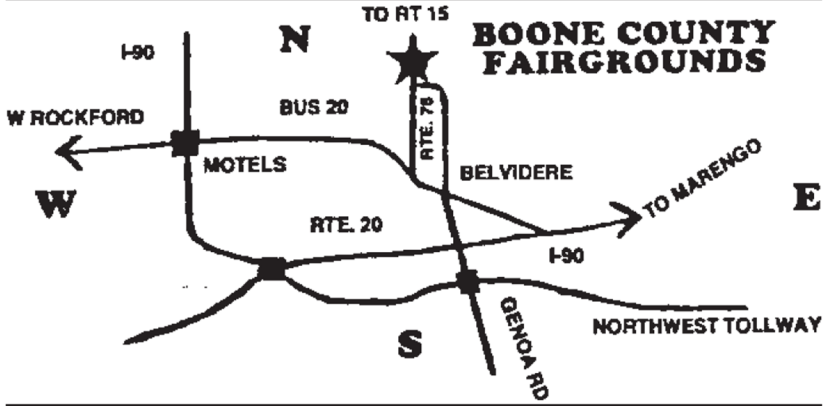

Directions to Animal Emergency Clinic of Rockford: Turn right out of the fairgrounds on to IL-76 N. In 1.2 miles turn left onto Spring Creek Rd. Continue for 6 miles. Turn left onto N Bell School Rd. Continue for 0.5 miles. Turn right on to Spring Creek Rd. The clinic will be 0.3 miles on the left side.

### Exhibitors Please Note

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

No dogs that are disqualified for aggression will be allowed to enter these Shows, nor be allowed to be on the grounds. In addition, no aggression reinstatement procedures will be performed at these Shows.

"Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment."
