ROUTES TO EVENTS

The address of the Peoria Civic Center is 201 SW Jefferson Ave, Peoria IL 61602 To Peoria Civic Center - Marquee Lot

From the East - Interstate 74 west to exit 93 (Adams St / Jefferson Ave). Turn left onto NE Jefferson Street (2nd traffic light). After passing through the intersection with Fulton Street, continue on Jefferson but move into the "right turn only" lane. This lane will take you into the Civic Center driveway and Marquee Parking Lot.

From the Northeast - Interstate 80 to Interstate 55 South to Interstate 74 west. Then follow the "from the east" directions.

From the North - I-39 south exit 14 (US-24 west). Turn left at the bottom of the exit to head west on US-24. US-24 joins US-150 west after approximately 27 miles. Continue over the bridge. Take the next exit for IL-29 south/Adams Street. Turn right onto IL-29/Adams. Adams Street becomes Jefferson Street when the street splits into 2 one-way streets. After passing through the intersection with Fulton Street, continue on Jefferson but move into the "right turn only" lane. This lane will take you into the Civic Center driveway and Marquee Parking Lot.

From the South - Interstate 155 North to Interstate 74 west. Then follow the "from the east" directions.

From the West - Interstate 74 east to exit 92B (Glen Oak Ave / Downtown Peoria). Move to the right lane after exiting. Bear right onto NE Glendale Ave (traffic light is there). Glendale will turn into William Kumpf Blvd. Turn left onto SW Monroe Street. Turn right at the first intersection onto Fulton Street. Turn right onto Jefferson Ave and move immediately into the "right turn only" lane. This lane will take you into the Civic Center driveway and Marquee Parking Lot.

To Peoria Civic Center - Fulton Lot -

From the West - Interstate 74 east to exit 92B (Glen Oak Ave / Downtown Peoria). Move to the right lane after exiting. Bear right onto NE Glendale Ave (traffic light is there). Glendale will turn into William Kumpf Blvd. From Kumpf turn left onto SW Monroe St. Turn left at the first intersection (Fulton St) into the Fulton Parking Lot.

From the East - Interstate 74 west to exit 93 (Adams St / Jefferson Ave). Turn left onto Monroe. At Fulton St (1 block after Main St) turn right into Fulton Parking Lot.

Attention Guests at All Hotels

- Dogs must be crated in rooms when unattended.
- Plastic must be placed under all crates in guest rooms.
- Dogs may not be bathed in the hotel room bathtub, and no grooming of dogs in the hotel rooms.
- Guests may not refuse cleaning service.
- All rooms are subject to examination by hotel staff and members of the show committee.
- Exercise your dogs only in designated exercise areas. You are responsible for cleanup.
- Damage to the hotel rooms or grounds will be considered "impairing a club's ability to retain a site" and will be grounds for an event hearing in accordance with AKC's Dealing with Misconduct Regulations. This can result in event suspension from 3 months to 1 year and fines from \$100 to \$1,000.
- Hotel guests are personally responsible for any damages to the hotel facility by their animals. Under no circumstance will the Club be held responsible or liable for any damage caused by individual guests.

Attention Host Hotels Guests:

The hotel parking garage height limit is 7'1". Oversize vehicles can park in the Civic Center's Fulton Street Parking lot nearest the hotels. Maps will be provided on the website. Due to the lack of grass immediately around the hotels, an exercise area (chips on top of plastic with temporary fencing) will be set up (under cover) on the ground level of the hotel parking garage. There is plenty of grass a short walk over to the Civic Center.

RV Parking

RV Parking will be in the *Fulton* parking lot at the intersection of Fulton and Monroe Streets. PCC has entrances on the Fulton lot side of the building for campers and others wishing to hand cart their grooming equipment from that parking lot. RV parking by reservation only. No overnight parking permitted without prepaid reservation. See website for information on nearby campground with hookups.



ATTENTION EXHIBITORS

Peoria Civic Center general parking is free for CCA attendees, but when other events are being held a parking pass will be needed. Visit the CCA information table in the exhibit hall to pick up a pass or to scan CCA's QR code to your phone. Parking will be available in the PCC's main Marquee lot, and additional parking will be available in the Fulton lot at the intersection of Fulton and Monroe Streets, across the street from the north side of the PCC. Utility trailers and oversize vehicles must be parked in the Fulton lot in designated areas.

- The show site will be open 9:00 AM to 11:00 PM Monday, 6:00 AM to 11:00 PM Tuesday through Saturday, and 6:00 AM to 10:00 AM Sunday.
- Security will be provided in the Peoria Civic Center overnight. All doors will be locked at 11:00
 PM each night. For dogs left in the building, all crates must be marked with responsible parties'
 contact info. Note that the Exhibit Halls are equipped with security cameras.
- NO OUTSIDE FOOD OR BEVERAGE ALLOWED in the Peoria Civic Center. There will be a
 concession stand available with a variety of foods, including salads and gluten free options.
- EVERYONE is REQUIRED to promptly clean up after their dogs! Failure to to do so will be grounds for an event hearing in accordance with AKC's Dealing with Misconduct Regulations.
- No gasoline or diesel generators are permitted inside or within 100 feet of any building.
- This is a non-smoking facility. No smoking is permitted within 25 feet of any entrance door.
- NO PARKING is permitted in the Peoria Civic Center loading dock. Only temporary parking for purpose of unloading or loading is allowed. Unauthorized vehicles may be towed.
- You have a responsibility to conduct yourselves in a manner that presents the sport of dogs and the Collie Breed in the very best light. Each and every time you appear in public with your dogs you have the opportunity to make a positive and lasting impression.
- The Peoria Civic Center and the RV parking lot must be vacated by Sunday, April 7, at 10:00 am.

- AED locations at the Peoria Civic Center: Nurse's Station in the Great Hall by the Reception Desk and in the Great Hall across from the Concession Stand
- Firearms and/or concealed handguns with or without a license are NOT PERMITTED at the Peoria Civic Center.

CCA POLICY

- CCA limits unentered dogs to no more than three dogs per grooming space/booking reservation. (per reservation - not per grooming space). However, please take into consideration that space is limited at this show site.
- Dogs under 6 months of age are not allowed.

ATTENTION EXHIBITORS

Use a common sense approach when visiting from out of state by making sure your Collies are up to date on all vaccinations. Use common sense practices in housekeeping by daily disinfecting your equipment and grooming areas both at shows and when you return home. Pay close attention to where you exercise your dogs, avoiding high traffic areas. Seek immediate veterinary medical assistance if your dogs show any signs of illness both at the show and when you return home. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

EXHIBITOR MOVE-IN

- Exhibitor move-in will start Monday, April 1, at 9:30 AM.
- To expedite the unloading process, after unloading your equipment and placing it in your grooming space you MUST remove your vehicle from the loading dock before setting up your grooming space.
- Vehicles will not be permitted inside the building.
- For move-in on Monday and Tuesday, use the Jefferson Street entrance to the Peoria Civic Center to access the loading dock; Do not enter the Peoria Civic Center from William Kumpf Blvd to access the unloading area. Please follow the signs and instructions from the Show Committee personnel managing the loading/unloading.
