WAITLIST FOR WITHDRAWN ENTRIES AFTER CLOSING DATE/TIME

A waiting list will be kept until **Friday, April 28, 2017**, to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 30 entries for each day will be placed on the wait list. Any entries received by the closing date/time that are withdrawn before the waiting list deadline will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. If an entry is cancelled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the trials. Any wait listed entry that does not move off the wait list into the trial by the waiting list closing date will receive a full refund.

DIRECTIONS TO THE TRIAL SITE

From East or West, I-40 to Exit 24, Lake Junaluska/Hot Springs. At end of exit take Hwy 209 South (Crabtree Road). Proceed approximately 2 miles; cross a large concrete bridge, and the Arena is on your left. From the South, take the Great Smoky Mountain Expressway (Hwy 23/74) to Exit 104 (East Waynesville/Hot Springs/Lake Junaluska). At the end of exit ramp, turn left onto Hwy 209 (Crabtree Road) headed north. Proceed approximately 1 mile; arena will be on your right.

FOOD: Concessions stand and/or food trucks will be available for breakfast and Lunch.

NOTICE TO EXHIBITORS

THE SAFETY OF THE DOGS IS OUR PRIMARY CONCERN: By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Puppies under 4 months of age are strictly prohibited from the grounds.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, by discretion of Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

The American Belgian Tervuren Club, the Trial Secretary, their agents, officers, members, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Obstacles shall meet the specifications for obstacles in the current edition of "Regulations for Agility Trials". Warm up areas consisting of a regulation jump will be provided for all exhibitors. Handlers are permitted to walk the course, without a dog, during a walk-thru period prior to the start of the class. Only handlers entered in the class are permitted to walk. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

DOGS ELIGIBLE TO ENTER on Monday, May 8, 2017: This trial is open to all dogs 15 months of age or older, that are registered with the American Kennel Club or that have obtained AKC ILP, PAL, or AKC Canine Partners Listing numbers, or are approved FSS breeds. Dogs with a PAL/ILP or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

DOGS ELIGIBLE TO ENTER on Tuesday, May 9, 2017: This trial is open to Belgian Tervuren ONLY that are 15 months of age or older, and registered with the American Kennel Club.

Bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance are not eligible to participate. Bitches in season may be withdrawn after closing, and entry fees (less \$6.00/run) will be returned upon request of the competitor prior to the start of judging. A veterinarian's statement is required.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of public enemy, or any other cause beyond control of organizing committee.

Exhibitors are responsible for entering correct classes and for being at the ring gate when it is their turn to run. All dogs must be leashed at all times when not in the ring or in designated warm-up area. Exhibitors are expected to clean up after their dogs. Crates may be left overnight; however, the ABTC and the Haywood County Fairgrounds will not be responsible for any lost or damaged items left at the show.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries will not be accepted. All entries must be made on official AKC Entry Forms or copies and must include the signed Agreement. No entry shall be accepted which specifies any condition as to its acceptance. Faxed or emailed entries will not be accepted.

Entry form changes, additions, corrections or cancellations must be received in writing prior to the April 6, 2017 closing date, be legible and include dog's name & owner's name. No telephone changes accepted. They may be emailed to jhabbot@charter.net.

MOVE UPS

SIMPLIFIED JUMP HEIGHT CARD PROCESS

If your dog needs to be measured, check the box at the top of the entry form so that your dog is placed on the Measuring List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during the day of show check-in. **It is the exhibitor's responsibility to have their dog measured prior to running. Failure to do so will result in the cancellation of any qualifying scores.**

RIBBONS AND AWARDS

Monday and Tuesday: Ribbons will be awarded for 1st-4th placements, each jump height, each class. Qualifying ribbons for qualifying scores. New Title rosettes will be awarded to all dog/handler teams finishing a title. HC Regular & HC Preferred (Master Std & JWW) will receive a rosette. MACH OR PACH rosette and decorated bar awarded for achieving those titles.

Tuesday, ABTC Specialty: Rosettes and ribbons awarded as above. Plus, 1st-4th in all classes awarded Tervuren-themed artwork and rosettes. HC Regular – Ribbon Quilt by Sew Creations, plus rosette. HC Preferred – Artwork by Mungo Works, plus rosette.

All ribbons, awards and trophies, if not awarded in the ring, must be picked up by the exhibitor at the trophy table by the end of the trial.

INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
