Beginner Puppies (4-6 months of age)

AKC Sanctioned Beginner Puppy Competition

Event Nos. **2022607905** [Following Saturday AM Specialty show]

The Four-to-Six Month Puppy competition shall be a combined class for dogs that are four months of age and over but under six months on the day of the event. Class open to only Vizsla puppies. Best of Breed 4-6 Month Beginner Puppy and Best of Opposite Sex to Best of Breed 4-6 Month Beginner Puppy

Entry and Eligibility requirements include: (For further information see www.AKC.org)

- AKC registration number or an AKC litter number will be required for all entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handles, members of their household and current assistants to professional handlers may not personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition. Dogs that are owned or co-owned by the forenamed may compete in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

Entry Fee: \$15.00 including AKC recording fee of \$2.00 for each dog. These fees are paid to the American Kennel Club.

Entries will close Wednesday, September 7, 2022 at the address shown on entry form.

Best of Breed Competition

The following categories of dogs may be entered and shown in Best of Breed competition: dogs that are Champions of Record and dogs that according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. Entering and showing dogs whose championships are unconfirmed is limited to 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's

records. If at the end of the 90-day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC.

Awards of Merit

A maximum of Four (4) Judge's Awards of Merit Rosettes shall be available for presentation by the Breed Specialty Judge to Vizslas he/she holds in high regard. Vizslas available for these awards shall be selected from the Best of Breed entry, plus Winners Dog and Winners Bitch, along with the Winners of the Veterans, Field Trial, and Hunting Classes. The Award of Merit winners will be selected after the Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch and Best of Winners awards are made. All dogs remaining in competition, including Winners Dog or Winners Bitch, are eligible for an Award of Merit.

NON-REGULAR CLASSES **INVOLVING SINGLE DOG ENTRIES (all specialties)**

Veteran Dog and Veteran Bitch

Open to dogs and bitches 7 years old and over. Classes are divided by age: 7 years and under 10 years, 10 years and under 12 years, 12 years and older. Neutered dogs and spayed bitches are allowed to compete in Veteran Classes at independent specialty shows. Only winners of these classes are eligible to compete in Best of Breed competition.

Combined Field Trial Dog and Field Trial Bitch combined with Hunting Dog & Bitch

Field Trail Dog & Bitch and Hunting Dog and Hunting Bitch requirements

Class for dogs and class for bitches who have a placement or a Judge's Award of Merit for an AKC licensed field trial. Exhibitor please have proof of the FT placement or JAOM with you on the day of the show. Hunting Dog/Bitch requirements for this combined class must have an AKC hunting title of JH, SH or MH. The winners of this class are eligible to compete in Best of Breed competition.

NON-REGULAR CLASSES **INVOLVING MULTIPLE DOG ENTRIES**

Stud Dog and Brood Bitch **(Saturday AM Shows ONLY)**

Stud Dog Class ~ For dogs and two of their Get that are entered in a Regular Class, Best of Breed Competition, or some other Non-Regular Class. The stud dog must appear in the ring with his get and be entered in the Stud Dog Class. The owner of the stud dog need not be the owner of the get. The awards will be based on the merits of the get.

Brood Bitch Class ~ The same as Stud Dog except substitute Brood Bitch for Stud Dog & Produce for Get.

Since the judge's decision in these classes will be based on the merit of more than one dog or bitch, not one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

While the merits of the stud dog or brood bitch are not to be considered in the placement of the entry, the stud dog or brood bitch must be examined to determine if it has a condition that would require disqualification or excusal under the Dog Show Rules, AKC policy or the standard for the breed.

AKC National Owner-Handled Series

(Remember to check the box in the owners' area on the entry form to qualify)

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form.

The handler must be an owner of record according to the AKC's records as of the date of the show. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog.

Dogs exhibited by professional handlers on the day of the event are not eligible for this competition. Dogs exhibited by current assistants and household members of a professional handler on the day of the event are not eligible to enter this competition. Current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed.
- If the Best of Breed winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to the Best of Breed is eligible, the Best of Opposite Sex to
- Best of Breed will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs or the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

***A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.*

SWEEPSTAKES: Both Friday AM and Friday PM shows

Sweepstakes is open to all Vizsla dogs and bitches 6 months of age and under 18 months of age on the day of the show. There is a \$20.00 entry fee per dog. The Sweepstakes Class must be specified in the "Additional Class" space on the entry form. Thirty percent of the entry fee is retained by the Vizsla Club of The Carolinas to defray expenses. Seventy percent is allocated toward cash prizes. Each dog or bitch must be entered in one of the regular classes at this show, i.e., Friday AM Sweepstakes must be entered in Saturday AM Specialty and Friday PM Sweepstakes must be entered in Saturday PM Specialty.

Veteran Sweepstakes is open to all Vizsla dogs and bitches 7 years old or over on the day of the show. They do not need be entered in another class.. There is a \$20.00 entry fee per dog. Neutered dogs and spayed bitches are allowed to compete in Veteran Sweepstakes Classes. The Veteran Sweepstakes Class must be specified in the "Additional Class" space on the entry form. Thirty percent of the entry fee is retained by The Vizsla Club of the Carolinas to defray expenses. Seventy percent is allocated toward cash prizes.

Rosettes are offered for Best in Sweepstakes, Best of Opposite Sex to Best in Sweepstakes, Best in Veteran Sweepstakes, and Best of Opposite Sex to Best in Veteran Sweepstakes. The Club retains 30% of the entry dollars to offset expenses. The remaining 70% is distributed according to the Prize Money Payouts below:

Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

PEE WEE CLASS SPECIAL ATTRACTION

Sunday, September 25, 2022 following the AM Specialty

Judge: Mrs. Karin B. Ashe

Entry Fee: No Charge

Entries taken at the club table Sunday morning until Junior Showmanship begins.

A Surprise Gift will be given to each entry.

Procedures and Guidelines

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5–9 years of age. Children younger than five cannot participate in the Pee Wee Class Special Attraction. The safety of the children is a primary concern.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- At a Group or Specialty Club Show the dogs must be of the breed(s) eligible for the event.
- It is up to the host club to decide if a dog must be registered to participate.
- A release must be signed by the child's parent or legal guardian. Please contact Event Operations at eventplans@akc.org to request the current version of the Pee Wee Release of Liability.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

It is essential that the club hosting this Special Attraction provide the support and time to greet the participants and make them feel welcome and be able to answer any question that may arise. There should be a minimum of three club members to assist participants, monitor the ring for safety, and one may act as the steward. Club members must be patient, pleasant, and willing to dedicate as much time as needed to create a pleasant experience for the young Junior and his/her adult. This is vital to the success of this program.

Each of these club members assisting should make themselves familiar with the Junior Showmanship Conformation Regulations, Guidelines for Judging Juniors in Conformation, Juniors in Performance Event Regulations booklet. It is recommended that these Regulations be available to those junior entrants at the show along with the Pee Wee class procedures and guidelines. (The club may download the PDF of the booklet or order from the Order Desk.)

Although the word "judge" will be used, this is designed to be a learning and mentoring experience—no Junior will be "judged" but rather will be mentored with the age-appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. Obviously, the older children can absorb more detail than the younger ones.

The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation ribbon or rosette to commemorate the experience. The club may select the color of the ribbon and may wish to add a small gift for the child or the dog to take home. It would be an added plus if the Judge were to be available for individual photographs with the show or club photographer which would serve as a memento and reminder to both the child and the adult of the fun experience and remind them to return again next year!

The Judge should explain the process of showing the dog to the Junior and the responsible adult in the ring including breed specific presentation. Depending on the size of the dog and the child, the adult may be asked to lift a table breed on or off the table, or the Club may mandate that the adult should do it regardless. Neither the youngster nor the adult should be asked to show the bite.

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

These Fees are paid to the American Kennel Club.

HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. - Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
