Recipients of Best of Breed, Best of Opposite Sex, Selects and Awards of Merit, and Best Bred by Exhibitor are eligible for entry in Crufts as a U.S. International Qualifier. Each will receive a Crufts eligibility Qualifying Award Certificate, which will be good for a Crufts Dog Show entry for March 2024 and March 2025 shows at the National Execution Centre (NEC) in Birmingham, England, United Kingdom. Certificate must be submitted along with each entry for Crufts to verify qualification. (No docked dogs are eligible to compete.)

If a Champion is entered in more than one class, it may not be exhibited in Best of Breed if it is defeated in ANY Regular or Non-Regular Class.

JUDGE'S AWARD OF MERIT

After awarding Best of Breed, Best of Winners, Best Opposite Sex, Select Dog and Select Bitch, the judge may, at his discretion, award up to a maximum of four (4) Awards of Merit to exhibitors in the breed ring that are, in the judge's opinion, outstanding specimens. The total number of Awards of Merit the judge is allowed to award is determined by the total number of dogs and bitches competing in the Best of Breed Competition as follows:

6-8 Entries (1); 9-12 Entries (2); 13-15 Entries (3); 16 or more Entries (4).

- All those in Best of Breed competition shall be eligible to receive an Award of Merit, except the Best of Breed, Best Opposite Sex, Select Dog and Select Bitch. The dogs must remain in the ring to receive the awards.
- The judge may withhold any or all of the AOM's for lack of merit.
- There shall be no limitation of the awarding of AOM's with respect to sex
- Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog and Select Bitch are NOT eligible for AOM, however both Winners Dog and Winners Bitch are eligible for AOM.

BEST PUPPY IN SHOW COMPETITION

Best Puppy – First place winners in Puppy 6 mos. and under 9 mos., Puppy 9 mos. and under 12 mos., and Bred-by-Exhibitor Puppy Classes (not divided by sex) will compete for Best Puppy. Judged after Best of Breed.

BEST BRED-BY-EXHIBITOR PUPPY & BEST BRED-BY-EXHIBITOR ADULT IN SHOW COMPETITIONS

Best Bred-by-Exhibitor Puppy – First place winners in the Bred-by-Exhibitor Puppy Classes will compete for Best Bred-by-Exhibitor Puppy. Judged after Best of Breed.

Best Bred by Exhibitor Adult – First place winners in the Bred-by-Exhibitor Adult Classes will compete for Best Bred-by-Exhibitor Adult. Judged after Best of Breed.

BEST VETERAN IN SHOW COMPETITION

Best Veteran – First place winners in Veteran Dog Class and Veteran Bitch Class will compete for Best Veteran. Judged after Best of Breed.

Each Veteran Class Winner is eligible for Best of Breed Competition, provided they have not been defeated in any other single entry class. Chapter 11, Section 8, neutered dogs & spayed bitches will be allowed to compete in Veteran Classes.

NON-REGULAR (Additional) CLASSES INVOLVING MULTIPLE DOG ENTRIES

Please Note: As the judge's decision in the Stud Dog, Brood Bitch and Brace Classes will be based on the merits of more than one dog or bitch, none of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won these classes.

Note: Neutered Dogs & Spayed Bitches are allowed to compete in Stud Dog & Brood Bitch Classes only at Independent Specialties (AKC Rules Applying to Dog Shows, Chapter 11, Section8).

Stud Dog Class: For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the Regular or Non-Regular Classes or if a Champion of Record, for Best of Breed Competition with the Stud Dog class being an 'Additional Entry' or may be entered for Stud Dog Class only at the Regular entry fee. The Get MUST be entered in one of the Regular Classes. The Stud Dog unit shall be considered as one entry and requires only one entry fee. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with his Get. Get only will be judged on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard of the Breed.

Brood Bitch Class: Same as Stud Dog but substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class: A Brace is defined as two dogs of the same recognized breed that are similar in appearance, performing in unison and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The dogs comprising a Brace MUST be named at the time of entry. If a dog which is to be part of a Brace is not entered in another class it must be entered for "Brace Class Only". In making entries for "Brace Class Only" full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes "Brace Class". If more than one Brace is entered by the same owner, the dogs comprising EACH Brace unit must be so designated "Brace No. 1", "Brace No. 2", etc.

Dogs MUST be entered in a regular specialty class or Best of Breed at the regular entry fee. Entries shall be made at the same time, on the same entry form as for Regular Classes. Entries of champions are accepted. No restriction on handler. Indicate Sweepstakes and age division on the regular entry form under "Additional Classes."

Puppy Sweepstakes Classifications

The following classes will be provided for both dogs and bitches:

Puppy, 6 Mo & Under 9 Mo • Puppy, 9 Mo & Under 12 Mo Junior, 12 Mo & Under 15 Mo • 15 Mo & Under 18 Mo

Veteran Sweepstakes Requirements

Veteran Sweepstakes is open to all Black Russian Terriers at least six (6) years of age on the day of the show. Spayed or neutered dogs are eligible. Dogs **Do Not** need to be entered in a regular class at the regular entry fee. Entries shall be made at the same time, on the same entry form as for Regular Classes. Entries of champions are accepted. No restriction on handler. Indicate Veteran Sweepstakes and age division on the regular entry form under "Additional Classes."

Veteran Sweepstakes Classifications

The following classes will be provided for both dogs and bitches:

6 years & under 9 years • 9 years and over

Bred-By-Exhibitor Sweepstakes Requirements

Bred By Exhibitor Sweepstakes is open to all Black Russian Terriers at least six (6) months of age on the day of the show. Dogs MUST be entered in a regular class or Best of Breed at a regular entry fee except veteran dogs aged 6 years and up. Veteran aged dogs may be neutered or spayed. Entries shall be made at the same time, on the same entry form as for Regular Classes. Entries of champions are accepted. Handler of the dog must be a breeder of record; ownership not required. There are no restrictions as to who may handle the dog in subsequent winner's class. Indicate Bred By Exhibitor Sweepstakes and age division on the regular entry form under "Additional Classes."

Bred By Exhibitor Sweepstakes Classifications

The following classes will be provided for both dogs and bitches:

6 months & under 9 months • 9 months & under 12 months
12 months & under 15 months • 15 months & under 18 months
18 months & under 2 years • 2 years & under 4 years
4 years & under 6 years • 6 years & under 8 years • 8 years & older

Working Dog Sweepstakes

The Working Sweepstakes celebrates the versatile working ability of the Black Russian Terrier. Dogs do NOT have to be entered in a regular specialty class. Dogs may be neutered or spayed. Dogs must have an AKC title in at least one of the following AKC performance, companion or working events: Agility, Barn Hunt, Coursing, Fast Cat, Farm Dog, Herding, Obedience, Rally, Scent Work, Tracking, Trick Dog. There are two classes divided by sex: Working Dog and Working Bitch. Indicate Working Sweepstakes on the regular entry form under "Additional Classes."

JUNIOR SHOWMANSHIP

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on

the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have won three (3) first place awards, with competition present, in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member

Master Class - for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

AKC SANCTIONED 4-6 MONTH BEGINNER PUPPY Friday, September 15, 2023

One combined class, not divided by sex, will be offered for Black Russian Terriers that are at least (4) four months & under (6) six months of age on the day of the competition. All of the puppies are exhibited in the same class and the only placements are **Best 4 & Under 6 Months Puppy** and **Best of Opposite Sex to Best 4 & Under 6 Months Puppy**.

Entry and eligibility requirements:

- *AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows. A foreign born dog may enter this class if it is registered in the country of origin.
- *All entrants are to be vaccinated in accordance with their veterinarian's protocol.

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are not permitted to exhibit in this competition. (Professional handlers are defined as any person who belongs or has belonged to a professional handler's organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.)

AKC National Owner-Handled Series

(Remember to check the box at the bottom of the entry form)

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in this competition.

Owner-Handled Best of Breed/Variety will be selected from the dogs that are eligible to compete in the Best of Breed/Variety competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group if offered.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed/Variety nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed/Variety including Winners Dog or Winners Bitch as the Best of Breed/Variety for the AKC National Owner-Handled Series.
 - If the Best of Winners is eligible, the other Winners are ineligible since it was defeated.
 - No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.
- *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- **A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might
 reasonably appear that the judge's placements could be based on something other
 than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able
 to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for the first entry in Rally and \$3.00 for each additional entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis. Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Judges need not wait for any dog holding up the class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.
