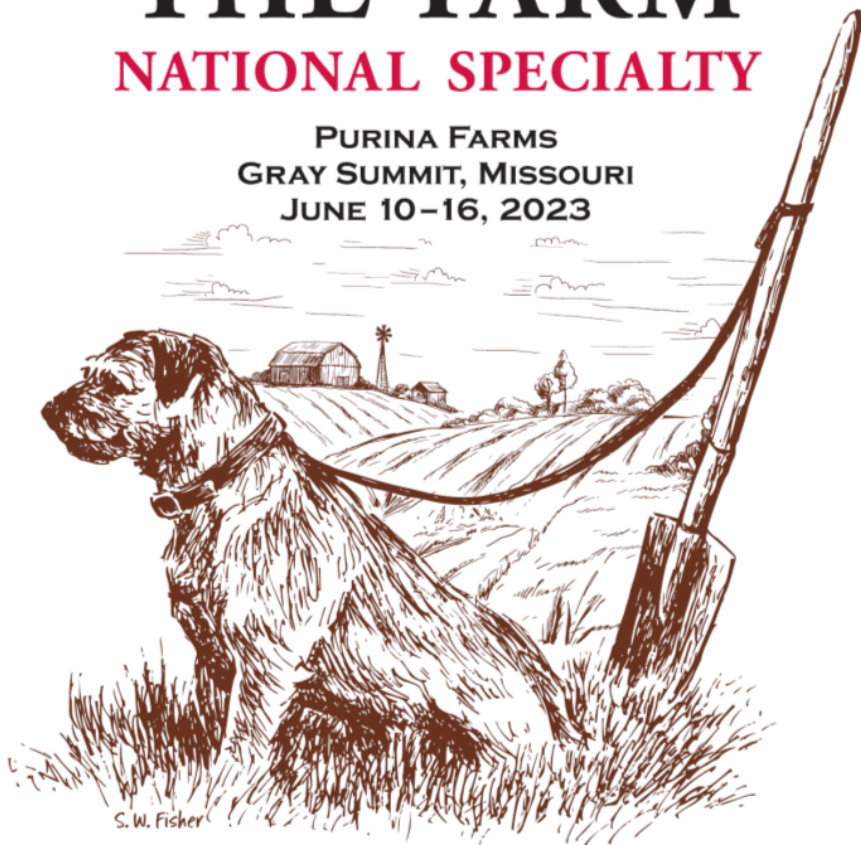

BORDER TERRIER CLUB OF AMERICA, INC. ROOM RESPONSIBILITY POLICY

The Border Terrier Club of America, Inc. has adopted the following rules in order to ensure that its members and their dogs will be welcome at hotels in the future.

Owner Responsibilities:

Any individual attending a BTCA sanctioned event and staying in a hotel, motel, inn, or campsite/fairground has the responsibility of leaving that room or campsite exactly as found. This includes picking up after dog(s) on the grounds. Anyone who damages a room or campsite/fairground and does not report the damage to the hotel/motel/campsite/fairground management and make immediate restitution or arrangements to do so within a period of time agreed upon by the management, will be **subject to any or all of the following actions by the BTCA Board of Directors:**

- May be banned from showing at the next BTCA sanctioned events(s).
- May be subject to AKC sanctions.
- Membership in the BTCA may be terminated and may not be allowed to be reinstated.

Damages shall be defined as:

- Flea infestation, urine, defecation and/or any damage to hotel/motel/campsite/fairground property (walls, bedspreads, carpets, drapes, etc.)
- Any verified complaint by the host/hotel/campsite/fairground.
- Any verified complaint by a BTCA member.

BTCA Room Regulations:

- All dogs shall be crated and quiet when left alone in a room. Noisy dogs shall be quieted upon request, even if this means the owner/handler must stay in the room with the dog.
- Individuals will be expected to immediately report any damage by dogs or themselves to the hotel/campsite/fairground management and to assume complete financial responsibility for that damage.
- No bathing or grooming of dogs will be allowed in rooms. A grooming room will be available whenever possible.
- Dogs are allowed to be on hotel furniture/beds ONLY if the furniture is covered with protective covering provided by the owner/handler.
- All owner/handlers will take preventative measures to assure that their dogs are free of fleas, mites, intestinal parasites, and other communicable diseases prior to arriving at the hotel/campsite.

Submission of an entry form and/or physical presence on the show grounds shall constitute both implied and real consent for both the handler and the dog to be professionally video recorded and streamed live only by the professional video services as contracted by the Club for this show. All rights to video record and live stream or otherwise exploit this event and/or the persons or animals participating in it, including the names, likenesses and biographical matter of dogs, owners, handlers, breeders and kennels participating in the event shall belong solely to the show giving Club and/or the American Kennel Club, Inc. No spectator, participant, owner, handler, breeder or kennel shall make commercial use of any video recordings of any person or animal participating in this event without prior written approval from the Club. This event may not be broadcast to social media (e.g. Facebook Live, etc) without prior written approval from the Club.

 **Camper will need to print, fill out, and send to Purina.**

- At that time, parties that wish to camp next to each other can indicate on the form.
- No tent camping is allowed.
- RVs can be rented from the companies listed on Purina Farms website (shown below) or from anyone of your choosing. **If you rent an RV, you will need to remember to also BOOK AN RV SITE!**

Purina Farms offers two options for camping at the facility:

- **Option #1: A full-service lot** with electric/water/sewer hook-ups.
 - Cost is \$40 per day.
 - Available after 3:00 pm on Sunday, June 11th.
- **Option #2: An electric- only lot** with multiple water spigots for filling freshwater tanks, but not for permanent hookup:
 - Cost is \$25 per day.

EXHIBITOR GUIDELINES

RINGSIDE: Dogs may arrive at any time prior to their scheduled time of judging. Judges will not wait for any dog. Owners and agents alone are responsible for the presence of their dogs at ringside when their class is called. The club, judges, stewards, and superintendent have no obligation or responsibility to announce for or locate dogs that are not at ringside when required.

BEHAVIORAL EXPECTATIONS: It is expressly understood that exhibitors alone are responsible for the behavior of themselves and their dogs and/or children.

- Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made.
- The club, hotel, superintendent, and any of their agents or employees will assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Exposing a dog to an unsafe environment, distress, or harm's way is considered mistreatment. The club solely determines if said animal is in distress or harm's way.
- Dogs found in an unsafe environment, distress, or harm's way (for example- left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety, and the club reserves the right to remove any animal in distress from a parked vehicle or crate or grooming table in any way necessary. All people attending this dog show hereby waive any claim for damages against the club for such removal.
- Flexi leashes are prohibited on show grounds.
- The show site will be available to exhibitors from 6 AM to 6 PM, unless otherwise specified. Dogs must be removed from the building immediately following the conclusion of judging on Friday, June 16th.
- NO DOUBLE HANDLING will be permitted at these shows. Individuals who attempt to double handle from outside the ring will be subject to action by the Show Committee.
- There shall be no drilling nor intensive or abusive training of dogs on the show grounds.
- Baby strollers are NOT allowed in the show building.
- Exhibitors are responsible for maintaining clean conditions around their grooming areas.
- Exhibitors are required to clean up after the dogs they are exhibiting, or which are under their care or control. This requirement includes both while in the ring or at any location on the show site. Clean up tools and supplies will be available at each ring and at other convenient locations.
- Final cleanup of the grooming area will be the responsibility of each owner. Clean up tools and supplies will be available at each ring and at other convenient locations.
- Crates must be stacked whenever possible.
- All passageways must be kept open; grooming and crates are not allowed in walkways, hallways, or lobby areas.
- Dogs are not permitted in restrooms, showers, or food areas.
- Parking in loading/unloading areas is prohibited- once unloaded.
- Tarps, towels, or other floor protection under crates in the crating/ grooming areas.
- No exercise pens, puppy playpens, etc. are allowed in the building.
- No unsupervised dogs allowed in outside ex-pens between 10:00 p.m. and 6:30 a.m.
- **At all times, be considerate of your fellow exhibitors.**

Non-Regular Classes (Additional) Involving Multiple Dog Entries

NOTE: *As the judges' decision in the Non-Regular Classes Involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class.*

Chapter 11, Section 8 of the Dog Show Rules provides that a "castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

STUD DOG CLASS: For Stud Dogs and TWO of their Get. The Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with its Get. Get MUST be entered in another Class. The owner of the Stud Dog need not necessarily be the owner of the Get. Only the Get is to be judged based on their merits, while the merits of the Stud Dog are not to be considered in the placement of the entry. Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show rules, AKC policy, or the Standard for its breed.

BROOD BITCH CLASS: Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS: Two dogs of the same breed and must have at least one common owner and presented by a maximum of two handlers. The dogs comprising a brace must be named at time of entry. Dogs must also be entered in a regular or non-regular conformation class. Champions of Record and altered dogs may be entered. "Brace" must be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated, "Brace No 1," "Brace No 2." Etc.

TEAM CLASS: Same as Brace, except substitute Team for Brace and four dogs and handlers for two.

BREEDERS CLASS: The Breeders Class is a multiple entry class consisting of 3-5 dogs regardless of sex. This class is open to all breeders. All dogs entered must have at least one breeder in common who must be present. The individual dogs comprising the entry must be from at least two different combinations of parents, but need not be owned or handled by the breeder. Entrants must be entered individually in some other conformation class. Each dog must be entered on a separate entry form and all forms submitted together.

Best Bred By Exhibitor, Best Veteran, Best Working

First place in each Bred By Exhibitor class will compete for Best Bred By Exhibitor. If a BBE class winner is Best of Breed or Best of Winners, that BBE dog/bitch will automatically win Best Bred By Exhibitor.

The AKC offers recognition to the Best Bred-By-Exhibitor dog or bitch at National Specialties, as well as a certificate for one free litter registration.

First place in each Veteran class will first compete for Best Veteran. If a Veteran wins Best of Breed, it will automatically win Best Veteran.

Winners of the Working Dog and Working Bitch classes compete for Best Working. If a Working winner wins Best of Breed, it automatically wins Best Working.

Best Otter Head

Best Otter Head is open to all conformation and performance entries at the Specialty. The judge will select that entry whose head best fits the breed standard. There is no entry fee for this competition. It is not necessary to sign up for Best Otter Head as a separate class.

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

- Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for the first entry in Rally and \$3.00 for each additional entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.
