POINTS FOR RESERVE:

The Canaan Dog Club of America will award at its National Specialty a three point major to Reserve Winners Dog/Bitch if the Regular Class Dog Entry is twice the required number for a five point major in the division where the National Specialty is held.

MOVE-UP POLICY FOR THE SPECIALTY AND TRIALS:

The Canaan Dog Club of America will permit a move-up to the next level class in accordance with AKC regulations. The request for a Move-Up must be made in writing and presented to the Superintendent at least 30 minutes prior to the start of the specified event, show or trial. Move-Up forms will be available at the Superintendent's Table.

Missouri state law requires all dogs participating in dog shows be free of clinical signs of infectious or contagious disease and must be vaccinated for rabies; dogs traveling from outside of the state are also required to have a certificate of veterinary inspection [Missouri Animal Health Requirements for Exhibitors (2 CSR 30-2. 040)].

Non-Regular (Additional) Classes Involving Single Dog Entries

(provided for both dogs & bitches)

Veteran Class (7 yrs & under 10 yrs) - A class for dogs seven (7) years & under ten (10) years of age. Veteran Class (10 yrs & under 13 yrs) - A class for dogs ten (10) years & under thirteen (13) years of age.

Veteran Class (13 yrs & older) - A class for dogs thirteen (13) years and older.

Note for Thursday: Neutered dogs and spayed bitches may be entered in the Veteran classes. Winners of the above classes are eligible for Best of Breed

Non-Regular (Additional) Classes Involving Multiple Dog Entries

(provided for both dogs & bitches)

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in those classes will be eligible to compete for Best of Breed by virtue of having won these classes.

Stud Dog Class - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog must be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, and MUST be entered in the Stud Dog Class. The Get MUST be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

Brood Bitch Class - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class - Two dogs of the same Breed or Variety of Breed with one or more common owner(s) and both dogs must be entered in another class.

Team Class - Four dogs of the same Breed or Variety of Breed with one or more common owner(s) and all dogs must be entered in another class.

Grandsire Class - Class offered for the grandsire and two consecutive generations of his get. While the consecutive generations (e.g. get & grand-get) must be entered in another class, only the Grandsire must be identified at the time of entry. The grandsire need not be entered in another class, nor does he need to be intact. Handlers of the Grandsire and all generations being exhibited, must wear armbands. Granddam Class - Same as for the Grandsire except substitute Granddam for Grandsire and Produce for Get.

AWARDS OF MERIT

The CDCA will offer Awards of Merit in recognition of the quality of dogs/ bitches in the Best of Breed Competition. It is solely the Judge's decision whether or not to give all available Awards of Merit, only one or some, or none at all.

Award of Merit recipients are selected from dogs and bitches in Best of Breed Competition, other than the Best of Breed winner, Best of Opposite Sex to Best of Breed winner, Best of Winners winner, Select Dog winner and Select Bitch winner.

The number of Awards of Merit that may be given is determined by the amount of dogs eligible for Best of Breed (entries in Best of Breed plus any Non-Regular Class Winners eligible for Best of Breed - i.e. Veterans, Herding Titled etc.)

The CDCA will offer competition for **Best Veteran**, **Best Puppy**, **Best Bred By Exhibitor Puppy**, **and Best Bred By Exhibitor Adult**. For all awards, prior awards may eliminate competitors. If not automatic due to prior awards, the competitions will be judged as such:

Best Veteran will be chosen from the first place winners in the Veteran Classes.

Best Puppy from the first place winners in the 6-9 and 9-12 month Puppy classes.

Best Bred By Exhibitor Puppy from the first place winners in the Bred By Exhibitor Puppy classes. Best Bred By Exhibitor Adult from the first place winners in the Bred By Exhibitor Adult classes.

BEST BRED-BY-EXHIBITOR IN NATIONAL SPECIALTY SHOW CRITERIA

If not automatic due to prior awards, the competition will be judged as such: Best Bred by Exhibitor In National Specialty will be open to the winners of the Bred By classes and any dogs in the Best of Breed/ Variety competition shown by their breeder/owner, including any non-regular class winners who are eligible for BOB.

• To be eligible for Bred-by-Exhibitor the appropriate box on the entry form (paper or online) must be checked.

• Every dog entered at this event is eligible for the Best Bred-By-Exhibitor Competition, if the entry is shown by a breeder-owner of record.

• All dogs in competition for Best Bred-by-Exhibitor, except International entries, must be individually registered with the American Kennel Club.

• Dogs in competition for Best Bred-by-Exhibitor must be handled throughout the entire breed competition by a breeder/owner of record.

• No handler change will be permitted for the purpose of becoming eligible for the Best Bred-by-Exhibitor competition.

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class at the show. **Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class at the show. **Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp). At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, Retrievers (Nova Scotia Duck Tolling, Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendeen, Whippet, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, Basset Fauve de Bretagne (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terrier, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. Please Check www.AKC.org for updates to this list. (eff 6/28/23)

RV PARKING GUIDELINES: There are seventy-four RV parking spaces behind the Purina Event Center. The fee for parking is \$40.00 a night in the full-service rows C & D, & \$45 a night in Row B and \$50 a night in Row A. It will be \$25.00 per night in the lower lot. AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

(American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for the first entry in Rally and \$3.00 for each additional entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.
