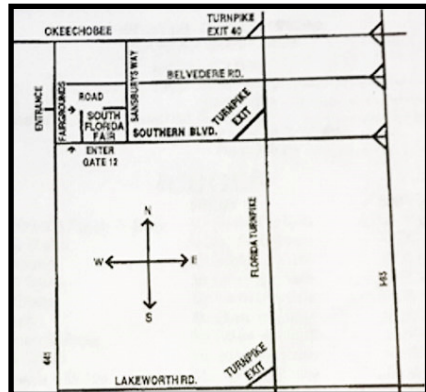

ATTENTION ALL SWEEPSTAKES AND VETERAN SWEEPSTAKES EXHIBITORS

The Event Committee has decided that the Golden Retriever Club of America Sweepstakes Guidelines, reformatted June 2000, updated November 2004, August 2006, May 2007 and Mid-year Board Meeting 2008 will be in effect at these shows. These rules, with the club's decision to adjust the age of Veteran's eligibility, are as follows:

Eligibility for Sweepstakes - Any purebred Golden Retriever 6 months of age and under 18 months of age on the day of the show and entered in any of the regular classes at the specialty show at which the Sweepstakes are held. Dogs which have completed the requirements for an AKC Championship (**according to AKC records**) prior to the closing date of the show at which the Sweepstakes are to be held are not eligible.

Eligibility for Veteran Sweepstakes - Any purebred Golden Retriever 7 years of age or over which is individually registered with the American Kennel Club (AKC) or the Canadian Kennel Club (CKC). Entrants need not be entered in any other class. AKC and CKC Champions of Record and spayed or neutered Golden Retrievers are eligible.

There are no restrictions to who may handle a dog in either puppy or veteran sweepstakes

Day of event parking is \$5.00. Enter Gate 12.

General Admittance Fee: \$5.00 for non-exhibitors. Children under 12 enter at no charge.

No crates allowed near rings except during judging of your breed. Do not block the aisles. This will be enforced by the Event Committee. **NO EXCEPTIONS!**

No Ex-Pens allowed in grooming area.

No Grooming Tables allowed inside except for grooming area.

Grooming Areas must be Kept Clean. NO SAVING SPACES. NO TAPING OFF SPACE.

Dogs should be exercised before coming into event buildings. PLEASE CLEAN UP AFTER YOUR DOG.

Absolutely No Smoking in Buildings.

No dogs permitted in any restroom! No cleaning of dog food bowls in restrooms.

Dogs must be kept out of all flower beds and posted areas.

Violators will be brought before the Event Committee.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for the first entry in Rally and \$3.00 for each additional entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis. Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
