Driving Directions

From Ft. Myers (45 minutes)

Hwy 31 is the best way to get to Arcadia from Ft Myers. So take Hwy 31 North to Hwy 70 West. Turn left onto Hwy 70 West and continue to Arcadia. Turn right onto Turner Rd. (Tractor Supply.) Turn right at light, on to Roan St. Civic Center is on the left.

From Port Charlotte (30 minutes)

From I-75 take Kings Highway east to Hwy 72. Turn right at Hwy 72. Continue to Hwy 70 East and take a right. Take Hwy 70 East to Turner Rd. Take a left at Turner Rd. (Tractor Supply.) Turn right at light, on to Roan St. Civic Center is on the left.

From Punta Gorda (30 minutes)

Pop-ups may be set up there. Also grooming is allowed in the livestock barn. There is electricity and water available in the livestock barn. There may be very limited free crating space on the second floor of the arena. Stackable crates only.

NOTE: Ringside grooming and crates will be allowed for no longer than 30 minutes prior to the the ring time of the dog and must be removed immediately after judging. Dogs not showing should not be brought to ringside. **ALL crates and grooming tables in the building MUST have identification on them with a legible, active cell phone number.** The Club reserves the right to move tables and crates/dogs to a secure area when they are left unattended for longer than 30 minutes or are not removed after judging and an Event Committee Hearing could take place.

Motor Home/Trailer Parking

No RV's or Camping (Day or Overnight) are allowed to use any Turner Agri-Center electricity or water without a paid permit

Overnight parking is available by reservation or on a first come, first serve basis upon arrival with additional fee. There will be full hookups as well as dry camping. Exhibitors will be allowed access to the grounds at 1:00 PM on Friday. Campers will self park in their assigned numbered 30-foot width space (between the lines) Your reservation confirmation will be sent to you through USPS mail. ONLY those with a displayed parking space confirmation paper will be allowed to stay overnight or hook up.

For those wanting to camp overnight without reservation, you must call 269-352-4011 or 269-352-4001 upon your arrival. You will be assigned a numbered space and given instructions if spaces are still available. Payment can only be taken by cash or check. An ATM machine is available inside the arena lobby. If your RV site is not a pre-paid reservation, there will be an extra charge of \$10 per night for non-reserved spaces (if available).

The classifications are provided for all breeds (and varieties). Additional divisions, (i.e. age, color, or weight) are in the breed list and must be indicated on the entry.

There will be Puppy, Bred By Exhibitor, & Open Classes for each of the Miscellaneous Breeds in each sex. Puppy and Bred-By classes will be divided by age if all-breed classes are divided.

Winners from these classes will compete for Best of Breed & Best of Opposite Sex to Best of Breed in each breed. Each Miscellaneous Best of Breed winner shall be eligible to compete for Best in Miscellaneous Class. All entries for Best in Miscellaneous Class shall be made after judging of the individual Miscellaneous breed classes. In the event that the owner of a dog designated Best of Breed shall not exhibit the dog in the Best of Miscellaneous Class Competition, no other dog of the same breed shall be allowed to compete. There shall be no further competition for dogs entered in the Miscellaneous Class. Ribbons shall conform to Chapter 5, Section 2 of AKC Rules.

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs

Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs

Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

AKC NATIONAL OWNER-HANDLED SERIES

FOUR ALL-BREED SHOWS - SATURDAY 1 & 2 • SUNDAY 1 & 2

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

"DON'T FORGET TO CHECK THE OWNER-HANDLED BOX ON THE ENTRY FORM IF ENTERING THIS COMPETITION."

All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes. The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp). At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, Retrievers (Nova Scotia Duck Tolling, Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendeen, Whippet, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, Basset Fauve de Bretagne (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terrier, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

NO DOGS ARE ALLOWED TO BE LEFT IN THE BUILDING OVERNIGHT.

- On Saturday and Sunday, please avoid entering or exiting the building through the rear lobby doors on Saturday and Sunday. The rear lobby is reserved for the CGC and ATT testing on Saturday and Sunday. You may enter those doors on Friday for set-up. Those with reserved grooming upstairs above the rear lobby may enter through the lobby and use the elevator or the stairs. Please do not be disruptive to the testing that is going on.
- You MUST clean-up after your dogs, inside or out. Dogs should not be permitted near any
 plant or shrub. Please place poop bags in trash barrels. Anyone not cleaning up after their dogs
 may be subject to an Event Committee Hearing.

All crates and grooming tables in the building MUST have identification on them with a legible phone number.

- Dogs in crates or trolleys are not allowed to be kept ringside except for 30 minutes prior to their ring time. Dogs and crates/trolleys must be immediately removed from ringside after their breed judging finishes.
- Dogs should not be left in locked cars unattended.

- Dogs May Arrive any time prior to their scheduled time of judging. Dogs not required for
 further judging will be excused. Judges Will Not Wait for Any Dog Holding Up a Class. Owners
 or agents alone are responsible for the presence of their dogs in the judging ring when their
 classes are called to be judged. All Dogs Present must be held on leash or confined to their
 crates.

Advanced CGC; The "CGCA" Title AKC Community Canine

AKC Community Canine is the advanced level of AKC's Canine Good Citizen (CGC) program. As with CGC, AKC Community Canine has a 10-step test of skills that dogs must pass to earn the official AKC Community Canine title. This is a title that appears on the dog's title record at AKC.

All skills on the test are tested on leash. The AKC Community Canine (CGCA) test may be done in a class, at shows, in pet stores or in the community. When the test is administered in community settings such as at a business or special event, evaluators must have the necessary approval of the business owners, etc.

While Canine Good Citizen tests are simulations of real world skills, (e.g., dog/handler walks through a "crowd" of evaluators in a ring), the goal of AKC Community Canine is to test the dog's skills in a natural setting. For example, rather than the dog being tested in a ring, in AKC Community Canine, the "walks through a crowd" test item will involve the dog walking through a real crowd at a dog show, on a busy sidewalk, in a therapy dog setting, or at a training club.

The "CGCU" Title - AKC Urban CGC Test as a Public Access Test

AKC Urban CGC is a title in the Canine Good Citizen family of awards and titles that also include AKC S.T.A.R. Puppy, Canine Good Citizen and AKC Community Canine.

AKC Urban CGC requires that the dog demonstrate CGC skills and beyond in a setting that includes traffic, crowds, noises, smells and other distractions that are present in a city or town. As with Canine Good Citizen, AKC Urban CGC is a 10-step test of skills that dogs must pass to earn the official AKC Urban CGC title. This is a title that appears on the dog's title record at AKC.

AKC Urban CGC is a public access test that demonstrates dogs are well-behaved and well-trained when in public settings. The Urban CGC test can be used by dog-friendly business (e.g., lodging, retail, transportation, public facilities) to recognize and accept dogs with good manners.

All skills are tested on leash. AKC Urban CGC should be administered in a place where there are cars, streets to be crossed, noises, and distractions. This test is administered in the real world; it should not be simulated in a ring at a dog show.

AKC Temperament Test In order to receive the title, the dogs must pass this test two times under two different testers. We offer two different testers so you could possibly get the title in one weekend.

Welcome to the AKC Temperament Test! There are 198 AKC recognized breeds. One of the things that makes a specific breed unique is not only the dog's physical appearance, but each breed also has its own distinctive temperament.

The AKC Temperament Test (ATT) was developed to bring focus and provide a meaningful evaluation to assess the temperament of our canine companions.

The ATT tests how a dog reacts to a variety of stimuli. Desirable traits are that the dog will be emotionally stable, inquisitive, cooperative, appropriately social for its breed, biddable and demonstrates the ability to recover from a startling situation in a reasonable amount of time.

Undesirable traits are fear, shyness, lack of cooperation and an inability to recover from unfamiliar or unexpected situations. Examples of undesirable behaviors include being afraid of friendly strangers or unfamiliar stimuli, obsessive barking, and aggression.

In the ATT, dogs are tested in 6 categories of stimuli that include: Social, Auditory, Visual, Tactile, Proprioceptive (motion) and Unexpected stimulus.

All of these tests will be done on Saturday and Sunday. If you pre-register for the tests, the cost is \$25 per test. If you wait until you get to the show, the cost is \$30, however that is IF there are still testing slots available. Please register for this early as it will sell out! To earn the ATT title, you will have to take the test two different times, under two different testers. We will have two different testers available, so it is possible that you could complete the title during the weekend.

There are five AKC Trick Titles you and your dog can earn:

AKC Novice Trick Dog (TKN)- Your dog performs 10 skills from the Novice list. (see link to "Application" below for lists of skills). If a dog has a Canine Good Citizen (CGC) certificate or title on record at AKC, it can do 5 Novice tricks (CGC + 5) to earn the Novice title.

AKC Intermediate Trick Dog (TKI) – Your dog must have the Novice title, plus perform 10 Intermediate tricks.

AKC Advanced Trick Dog (TKA) - Your dog must have the Intermediate title, plus perform 10 tricks from the Advanced list.

AKC Trick Dog Performer (TKP) – In this title, handlers perform a short routine with at least 10 tricks with at least 3 tricks using props.

AKC Trick Dog Elite Performer (TKE) – In the highest level of Trick Dog, the Elite Performers perform a routine that has a story/script. At least 5 props are used.

The testing for all titles will be done during show hours in the rear lobby area. The fee charged is for the test only. To get the title, you will need to send the application and required fee per CGC, Trick Dog and/or ATT to AKC.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might
 reasonably appear that the judge's placements could be based on something other
 than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able
 to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

(American Kennel Club Rally Regulation, Chapter 1, Section 5).
