## ROUTE TO THE SHOW

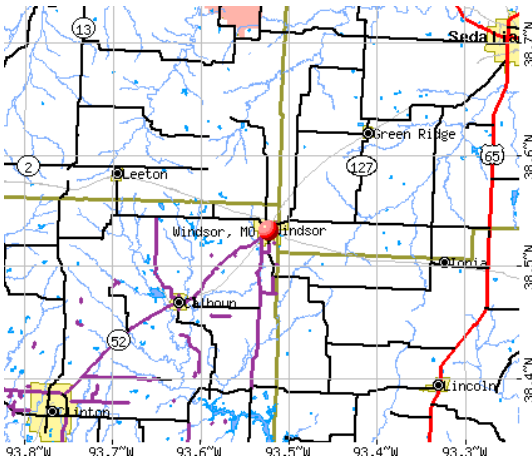
### From Kansas City:

Turn left on NE Highway 2 (MO-2) towards Windsor for 3 miles  
Continue on W Benton St (MO-2) for 1 mile  
Turn left on N Main (MO-52) for 1 mile  
Turn right into the parking lot Mutts, Manners, and More, LLC

### From 65 highway:

Head West on 52 highway for 15 miles  
Continue on N Main (MO-52) for half a mile

## NOTICE TO EXHIBITORS

Entry Fees include \$3.50 AKC Event Fee and \$.50 AKC recording fee.

Dogs will be shown indoors in an air-conditioned building - crating area is very limited. Crating will need to be done outside in the parking lot. .

THERE WILL BE NO ALCOHOL ALLOWED ON THE PREMISE.

Dogs need be present only for judging. ALL DOGS MUST BE OUT OF THE BUILDING 1 HOUR AFTER JUDGING ENDS. NO EXCEPTIONS!

Entry fees will not be refunded in the event a dog is absent, disqualified, excused by the judge or barred from competition by action of the Trial Committee.

If because of riots, civil disturbances or other acts beyond the control of the match-giving club it is impossible to open or complete the match, no refund of entry fees will be made.

Dogs must be ready for judging. The owner or handler of each dog is solely responsible for having such dog ready at ringside when his class is ready to be judged.

Space will not be provided at this trial for un-entered dogs.

The trial-giving club and its membership assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or any of their dogs or property, and further assume no responsibility for injury to children.

Officers and members of the Sedalia Kennel Club will exhibit dogs at this trial.

Exhibitors and handlers will be held responsible for clean conditions in and around their crating and grooming area.

Parents will be held responsible for the conduct of their children at this trial.

No entry shall be made, and no entry shall be accepted, which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.

Changes, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Those received by telephone are not acceptable.

## AGREEMENT

I (we) acknowledge that the "Rules Applying to Dog Shows/Registration and Discipline" and, if this entry is for an obedience trial and/or agility trial, the "Obedience Regulations", and/or the "Agility Trial Regulations", have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under the "AKC Rules, Regulations and Guidelines". I (we) agree that the club holding this show, obedience trial and/or agility trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show, obedience trial or agility trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or agility trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this show or obedience trial or agility trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

## INSTRUCTIONS

- (Variety) if you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard), Collies (rough, smooth).
- The following categories or dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in the show's premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).
