A Pee Wee Special Attraction will be held **Saturday, April 6**, after the conclusion of Junior Showman-ship judging & presentation of the Tuff Quest Scholarship. Entries accepted April 5 & 6 only (no preentries). Entry fee is \$5.00. Entries limited to no more than 10 children. The entry form and a release must be signed by the child's parent, legal guardian, or a responsible adult.

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5–9 years of age. Children younger than five or older than eight cannot participate in the Pee Wee Class Special Attraction. Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- The dog must be at least six months of age.
- Bitches in season will not be allowed to participate.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult
 is to maintain control of the dog outside of the ring.
- The dog must be a Collie.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

The Bred-by-Exhibitor Class shall be for dogs that are: Six months of age or older as of the first day of the show. Not Champions of record on the date of closing of entries for the show. Individually registered with the American Kennel Club as of the date of closing of entries for the show. Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which the dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to whom may handle.

EXHIBITORS NOTE: If Champions are entered in more than one class they may not be exhibited in Best of Variety if they are defeated in ANY Regular or Non-Regular Class.

Owner of the Stud Dog need not necessarily be owner of the Get. Get only to be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under Dog Show Rules, AKC policy or the standard of the breed. Get must be entered in a Regular Class, Best of Breed Competition or its form the Non-Regular Class.

Brood Bitch Class - Same as Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace - (Two Dogs of the same variety and must have at least one common owner and presented by a maximum of two handlers.) - The dogs comprising a Brace MUST be named at time of entry. If a dog that is to be part of a Brace is not entered in another class, it must be entered for "Brace Class Only." In making entries for "Brace Class Only," full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as a part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated, "Brace No. 1," "Brace No. 2," etc.

As the judge's decision in the Non-Regular Multiple Dog Entry Classes are based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won these classes.

To be eligible for this award, a Collie must participate in at least three of the four AKC events offered by the CCA (**Breed, Obedience/Rally, Agility or Herding**).

Sign up for the award at any performance event. You must sign up for the award to be eligible, and sign up sheets must be turned in to Beth Elliott by the end of the Agility Trial. The detailed rules for determining the winner from the Collies that qualify for the award are given below. Note that weighting factors are used in each of the performance events to recognize the increased difficulty of the higher-level classes. In the non-Best of Variety classes, points are awarded based on the number of dogs defeated in the class. All scores will be recorded from the posted Judge's sheets. Beth Elliott will maintain the official scores at this show. The award presentations will be announced on Saturday, April 6, 2024 in the main conformation ring (time TBA).

RULES FOR THE MOST VERSATILE COLLIE AWARD

To be eligible for this award, your Collie needs a qualifying score in at least three of the four AKC events at the National Specialty. A Collie that receives MVC points in Breed is considered to have received a qualifying score in that event. Only one score will be counted for each event. The Collie obtaining the highest point total will win the award. The following scoring system will apply: **BREED:**

- All Collies that are a conformation champion or have at least 5 Championship points will receive a minimum of 40 MVC points for entering and showing in a conformation class at the CCA National.
- Collies with less than 5 Championship points will not automatically receive any MVC points for showing in a conformation class. Points will only be awarded for placing in a class and defeating competition.

Since this is an individual award, Brace Class performances do not count.

No points will be awarded to Collies entering a conformation class and not showing (i.e., marked absent).

In the BOV class and Winners competition, points will be awarded as follows:

Making no cuts: 40 points Reserve Winners: 75 points Making first cut: 50 points Winners: 80 points Making second cut: 60 points Best of Winners: 85 points Making third cut: 70 points Opp. Sex to BOV: 90 points Awards of Merit: 80 points Best of Variety: 100 points

Placements: Two (2) additional MVC points are awarded for every dog defeated in the class up to a maximum total number of 70 MVC points. (Collies with less than 5 CH points will also receive the base 40 MVC points for placing and defeating dogs in a class.)



Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or

judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor the Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging.

Judges need not wait for any dog holding up the class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.

PUBLICATION RIGHTS By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
