ATTENTION EXHIBITORS

Show grounds will be available at 6:00 A.M. on Saturday and Sunday, February 10 and February 11 2024. No Dogs will be allowed in the grounds overnight at these events, except in motor homes. DOGS MUST be removed from the grounds immediately following Best in Show each day. GATE opens at 6:00 A.M. Saturday and Sunday, February 10 and February 11, 2024, the gate closes at 10:00 P.M. every night.

No electricity will be available around the rings. It is prohibited to use the electricity outlets around the rings in the arena.

Unloading your vehicle. You have 20 minutes to unload and must immediately move your vehicle

PARKING

Parking in the north lot beyond the admission gate and behind the stables near the arena is **\$5.00** per day. Stalls rented for reserved grooming will include 1 parking space (must pay additional \$5.00 to park on show grounds at the gate) and electric hookup in front of the rented stall. Only reserved grooming cars may park in front of those stalls.

All cars without reserved grooming sign and receipt in the window may be towed at the owner's expense. The reserved grooming receipt must be displayed in the windshield of the vehicle.

Any vehicle that connects to electricity by the stables will be charged for reserved grooming. If you would like reserved parking and grooming please fill out the reserved grooming form in advance and mail it in with payment to reserve your space.

There is no parking on the grass except for reserved and paid motor homes in their assigned spaces. All Motor Homes must wait by the white fence on the right side of the parking lot (west) upon arrival for check in. After checking in you will be escorted to your assigned space. You must display your motor home parking receipt in your window on the driver's side dashboard window.

You may not park on the grass by the arena

Admission to Show:

Admission is included in paid parking. February 10 and February 11, 2024 for people walking into the show, not paying for parking. \$5.00 Adult - \$2.00 Children 6 to 12, Senior Citizens (55 and over) and Children under 6 are Free. *Important to know: you will be asked for your dog's entry form at the GATE to be admitted for free. One free admission for each dog entered. Having dogs in your vehicle does not prove your dog is entered. If you do not provide the entry ID, you will be charged admission to the show. No exception. This regulation applies to dogs entered in conformation. Dogs not entered and not competing are not allowed on show grounds

Please Note: Tropical Park Rule. There is No overnight camping allowed except in camping area. Any vehicle found in another area will be towed at owner's expense. Exhibitors and Handlers will be held responsible for clean conditions in and around their crates and parking spaces. Anyone not cleaning up after their dogs will be subject to an event committee hearing. **CRATES ALLOWED RINGSIDE ONLY FOR THE DURATION OF JUDGING AND MUST BE REMOVED IMMEDIATELY AFTERWARD.** There will be no grooming in show areas. There will be very few chairs available at this location. Bring your own chairs. Soft sided crates only allowed ringside while dogs are waiting to be shown. No dogs are to be left unattended in soft-sided crates. Crates must be stacked due to limited space. No roping off of space. This will be strictly enforced due to limited space. Exhibitors must be governed by any rules or regulations of civil authorities and/or building or location. Please, obey all posted signs. No strollers in arenas. **(IN ACCORDANCE WITH FIRE CODE).** Vehicles parked in restricted zones will be towed at owner's expense. Paid parking Voucher must be displayed on windshield at all times.

All dog show participants will be expected to clean up their area in grooming, and any hair that may accumulate on the ground due to said grooming. The park employees request a clean up of all fur, hair and trash left on the grounds be picked up and placed in trash cans. The South Dade Kennel Club appreciates your cooperation.

Failure to do so will result in disciplinary action.

Saturday

A New Exhibitor Briefing will be held during this Show. The Briefing location and time will be posted in the Judging Program. Spectators are welcome to attend.

Attention Vendors Only Arena will be available on Friday, February 9, 2024 at 12 Noon and out by 3 PM. Vendors must unload their merchandise and move their vehicles out of the way as soon as possible. **VEHICLES ARE NOT ALLOWED INSIDE THE ARENAS!**

NOTICE TO DOG OWNERS AND EXHIBITORS

When you sign the entry form you automatically agree to the following terms concerning Motels extending their place to you. The following rules have been established for the good of all concerned.

1. Plastic sheeting is to be placed under every crate in motel rooms.
2. Dogs must be crated when owner is out of the room. **NO EXCEPTIONS.**
3. Dogs must be kept on leash at all times while in the motel lobby or on motel grounds. Rooms and lobby must be kept clean of dog debris.
4. Dogs should be exercised in designated areas on motel premises. Every dog owner is expected to pick up after his own dog and dispose of waste in designated trash cans.
5. Due to severe clogging problems with drain pipes, **NO DOG MAY BE BATHED IN MOTEL.**
6. Rooms will be inspected daily by members of motel staff and observed violations or damages will be reported to hotel management and investigating committee.
7. Investigating committee, working with a fair and equitable system, is charged with investigating complaints.
8. Each dog owner/registrant is expected to cooperate with the investigating committee, hopefully settling damage claims on the spot or else must be willing to furnish information as to insurance policy number and other pertinent information required or requested.
9. Should a motel, for cause, deem it necessary to cancel room privileges, the registrant agrees to forego legal action against clubs and motels.
10. As an exhibitor, I am aware that violations may be referred to the Event Committee if written charges are preferred. If such charges are upheld by the Event Committee, it may lead to suspension from further show privileges.
11. Motels have the right to charge a pet deposit, refundable or non-refundable.
12. **Grooming Areas:** Equipment may be left overnight **in Designated Grooming Area Only. DOGS MAY NOT BE LEFT OVERNIGHT UNATTENDED.** Multiple crates must be stackable. Exhibitors will be responsible for clean conditions in and around their crates and exercise pens. Aisle ways must be kept open. Exercise pens will be limited at the discretion of the Cluster Coordinator. No washing dogs or food bowls in restrooms. Restrooms will be locked after Best in Show.

Exhibitors, please clean your rooms and pick up grounds after your dogs in order to ensure use of these motels in the future.

ATTENTION OWNERS/EXHIBITORS OF FOREIGN REGISTERED DOGS

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1.

Most important to note are the following:

1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension.

If you have questions or need assistance with registration or obtaining an extension, please contact the AKC Special Services Department at: awards@akc.org or (919) 233-9767 (followed by selecting option 4).

The Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in this premium list and assumes all risks involved.

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs

Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, Retrievers (Nova Scotia Duck Tolling), Spaniels (American Water), Spaniels (Boykins), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendéen, Whippet, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terrier, Soft Coated Wheaten Terrier, Staffordshire Bull Terriers, Finnish Spitz, Australian Cattle Dog, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, Basset Fauve de Bretagne (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi. Pulik.

The following breeds must be judged on a ramp through all levels of conformation competition: Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terrier, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

AKC NATIONAL OWNER-HANDLED SERIES

February 10, 2024 & February 11, 2024

AFTERNOON SHOWS

Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form.

The handler must be an owner of record according to the AKC's records as of the date of the show.

Dogs declared eligible will be identified by an asterisk or other representative mark in the steward's book and in the show catalog.

**Professional handlers, household members and current assistants to professional handlers may not exhibit. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.*

Dogs must be handled by an owner-handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner-handler for all AKC National Owner-Handled Series competition.

The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. *This excludes all dogs defeated during class and winners competition for the regular show.*

If the Best of Breed/Variety winner of the regular show is eligible for the AKC National Owner-Handled Series competition, it will also be awarded Owner-Handled Best of Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for the AKC National Owner-Handled Series.

If the regular show Best of Breed/Variety winner is not eligible for AKC National Owner-Handled Series competition and the regular show Best of Opposite Sex to Best of Breed/Variety is eligible, the regular show Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed.

If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety from the regular show is eligible for the AKC National Owner-Handled Series competition and both the Select Dog and Select Bitch are eligible, the judge is to choose Owner-Handled Best of Breed from the Selects and any eligible Winners Dog or Winners Bitch.

If one of the Selects from the regular show is eligible for AKC National Owner-Handled Series competition, excuse all eligible champions and non-regular class winners of the same sex and then choose Owner-Handled Best of Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.

If the regular show Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed including Winners Dog or Winners Bitch as the Owner-Handled Best of Breed.

If no dog remaining in the ring is eligible for the AKC National Owner-Handled Series competition, Owner-Handled Best of Breed will not be awarded and the breed/variety will not be represented in group competition for the AKC National Owner-Handled Series.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog within the last five years.*

These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Judges need not wait for any dog holding up the class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.
