#### **AKC NATIONAL OWNER-HANDLED SERIES**

#### **SATURDAY & SUNDAY**

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

#### USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, Retrievers (Nova Scotia Duck Tolling, Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendeen, Whippet, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, Basset Fauve de Bretagne (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terrier, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.



#### ATTENTION EXHIBITORS

#### PARKING

Exhibitor and visitor parking will be located on blacktop parking lots in front of Purina Event Center. Vehicles are limited to **ONE PARKING SPACE**. No ex-pens or crates allowed on blacktop, but are allowed on grass areas. No cones allowed in parking areas. **NO PARKING IN ROADWAYS** or next to building. St. Charles (MO) Kennel Club, Inc. parking committee will be in charge of all parking for this event.

#### **RV PARKING**

There are seventy-six RV parking spaces located behind the Purina Event Center, with 50 and 30 amp electric, sewer and water hookup (water may not be available in winter months). Once all of the RV parking spaces behind the Purina Event Center are full, then the Overflow lot would be used. Reservations should be made direct with Purina, see Rules and RV Parking Application on Page 24

#### **GROOMING & CRATING**

Grooming and crating in designated areas only. Grooming in the Purina Event Center will be 5 x 10 foot spaces. The fee for grooming with electricity is \$30.00 for the entire event (see grooming space application on page 22). There will be a limited number of reserved grooming spaces with no electric at a fee of \$15.00 for the entire event, with a limit of one (1) space per person, until all spaces are sold. Reservations will be accepted until Wednesday, January 17, 2024 at 6:00 pm. There will be limited free grooming spaces available with no electric, with a limit of one (1) space per person, NO SAVING OF SPACE IS ALLOWED. THERE WILL BE NO ELECTRIC CORDS ALLOWED IN FREE GROOMING AREA. Anyone found with dryers or electric cords in free grooming will face an event committee hearing & will be removed from the building. The free grooming area will be clearly marked. Exhibitors in free grooming are required to stack crates & limit the number of grooming tables to maximize space.

Any crates in Great Hall should have a covering underneath them, whether it is a towel, rug, plastic, etc to help protect floor from damage. All Grooming Tables must have rubber or plastic caps on the end of legs. All Grooming Exhibitors are responsible for keeping their grooming areas as clean as possible each day & cleaning up all hair in your space before leaving the site. Crates placed ringside for showing MUST be removed immediately after the showing of your dog, they may not be left overnight.

The Purina Event Center will be available at 12:00 pm on Friday. Do not arrive before 12:00 noon. Bathing of dogs is restricted to bathing area of the building - no dogs allowed in restrooms. The Purina Event Center will close & doors will be locked at 10:00 pm & will re-open at 6:00 am. Guards will be on duty. Dogs may be left inside the building on Friday & Saturday nights only. In accordance with AKC policy, each dog that is left in the facility overnight must be identified with a tag stating the owner/agent's name and where they can be reached in case of an emergency. In the event of multiple entries, one tag will be sufficient provided it clearly outlines the number of dogs & the area in which they are crated. No cones, baby strollers, ex-pens, cocker pens or puppy pens allowed inside the building at any time. Please stack your crates and limit the number of grooming tables. All vehicles must leave their headlights on while loading & unloading in the designated loading/unloading areas which are clearly marked. No vehicles may park in roadways to unload.

#### **EXHIBITORS & GUESTS**

No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance". These are separate divisions of Purina and are not part of the show grounds. No dogs are allowed on the second floor of the Purina Event Center. No baby strollers, private golf carts, firearms or cones allowed on Purina Property or inside Purina Event Center.







# AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might
  reasonably appear that the judge's placements could be based on something other
  than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able
  to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

These Fees are paid to the American Kennel Club.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis. Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or

judge, or barred from competition by action of the Show Committee.

The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.
