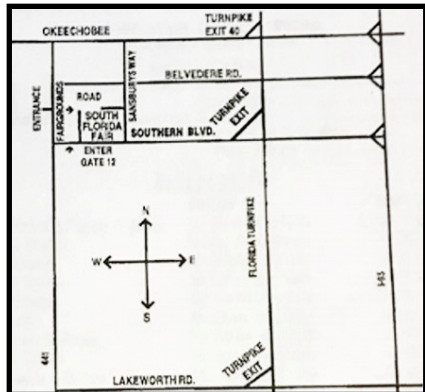

Best Bred-By-Exhibitor in Group Competition Saturday Judge: Eugene Zapheris

The winners of the Bred by Exhibitor Dog and Bred by Exhibitor Bitch Classes in each Breed/ Variety will compete for Best Bred by Exhibitor in Breed/ Variety following Best of Breed/ Variety judging in each Breed/ Variety. If the Best of Breed/ Variety or Best of Winners is the winner of a Bred by Exhibitor Dog or Bred by Exhibitor Bitch Class, that dog/ bitch is automatically Best of Breed Exhibitor in the Breed/ Variety. The Best Bred by Exhibitor in each Breed/ Variety will compete for Best Bred by Exhibitor in Group.

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs

Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs

Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

NOTICE TO EXHIBITORS AND VENDORS

The club will be in compliance with COVID-19 safety precautions in place at the time of the event. Depending on the conditions and circumstances at the time of the shows, we may choose to eliminate Special Attractions and any other events the clubs deem necessary. We appreciate your cooperation and understanding. By entering these shows you agree to do your best to follow all "best practices" in effect during the cluster and that you will not hold either Club of The South Florida Fairgrounds liable for any condition that might arise while you are in attendance.

Camping will be permitted at the Fairgrounds and will be available to campers starting **Tuesday, March 19** Full hookups (water, sewer and electric) are available for **\$70.00 per night**. The South Florida Fairgrounds has a limited number of camping spaces for these events. The on site spots are **FIRST COME, FIRST SERVED. ONLY handicapped persons or vehicles** will be allowed access through gate 10. This is the area back of the west expo across from stockade. Handicapped mirror tag, identification card or license plate are required. **Each camping space has electric, water and sewer hookups. Campers must bring their own cords and connections. Please check in with security for your space assignment. X-pens must be set up within your site. All RV parking is handed by the South Florida Fairgrounds and you must follow their rules.**

Day of event parking is \$5.00. Enter Gate 12.

Outside exercise areas: Dogs should be exercised before coming into event buildings. PLEASE CLEAN UP AFTER YOUR DOG.

Absolutely No Smoking in Buildings.

No dogs permitted in any restroom! No cleaning of dog food bowls in restrooms.

Dogs must be kept out of all flower beds and posted areas.

Violators will be brought before the Event Committee.

Attention Owners/Exhibitors of Foreign Registered Dogs

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1.

The Dog show rules are posted on the AKC Web Site at <http://images.akc.org/pdf/rulebooks/RREGS3.pdf>.

Most important to note are the following:

1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web Site at <http://images.akc.org/pdf/extenap.pdf>.

Notice to Exhibitors

Telephone Entries and Unsigned Entries Cannot Be Accepted. Entries Not On Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for the first entry and \$3.50 for each additional entry at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for each entry in Rally (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

To find out about any AKC event cancellations, call the AKC Event Cancellation Hotline 877-252-3229.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor the Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging.

Judges need not wait for any dog holding up the class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**
