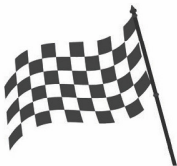

Miscellaneous Breeds

There will be Puppy, Bred By Exhibitor, & Open Classes for each of the Miscellaneous Breeds in each sex. Puppy and Bred-By classes will be divided by age if all-breed classes are divided.

Winners from these classes will compete for Best of Breed and Best of Opposite Sex to Best of Breed in each breed. Each Miscellaneous Best of Breed winner shall be eligible to compete for Best in Miscellaneous Class. All entries for Best in Miscellaneous Class shall be made after judging of the individual Miscellaneous breed classes. In the event that the owner of a dog designated Best of Breed shall not exhibit the dog in the Best of Miscellaneous Class Competition, no other dog of the same breed shall be allowed to compete. There shall be no further competition for dogs entered in the Miscellaneous Class. Ribbons shall conform to Chapter 5, Section 2 of AKC Rules.

The Grand Traverse Kennel Club, as part of its All-Breed Show 1 on Friday, will hold a Best Veteran in Show Competition. Competition will be for Best Veteran in Breed/Variety and Best Veteran in Show. There will be NO Veteran Group Competition.

During the course of judging, the assigned judge will select a Best Veteran in Breed/Variety. Dogs and bitches in this combined class MAY BE altered and WILL NOT compete for the points or in Regular Best of Breed Competition. This will be judged AFTER Best of Breed/Variety judging. All Best Veteran in Breed/Variety winners will compete for Best Veteran in Show.

Best Bred by Exhibitor in Show Competition

The Bred By Exhibitor Puppy and the Bred By Exhibitor Adult will compete in Bred By Exhibitor Groups and Best Bred By Exhibitor in Show. Judges, Group Order, and Ring times will be announced.

6-9 Puppy, 9-12 Puppy and the Bred By Exhibitor Puppy in this extravaganza will culminate to the Best Puppy in Show award. In this special event, Puppy class Winners in each breed/variety will be judged immediately following Best of Breed to determine Best Puppy. If a puppy wins Best of Breed/Variety or Best on Winners, it is automatically Best Puppy for that breed/variety. The Best puppy then competes in its respective Puppy Group and First through Forth placements. The first Place puppy Group winners will compete for Best Puppy in Show.

4-6 Month Beginner Puppy Competition

Judge Mrs. Danelle M Brown

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four- to-Six Month Puppy in Show.

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for all entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*

Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years old on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

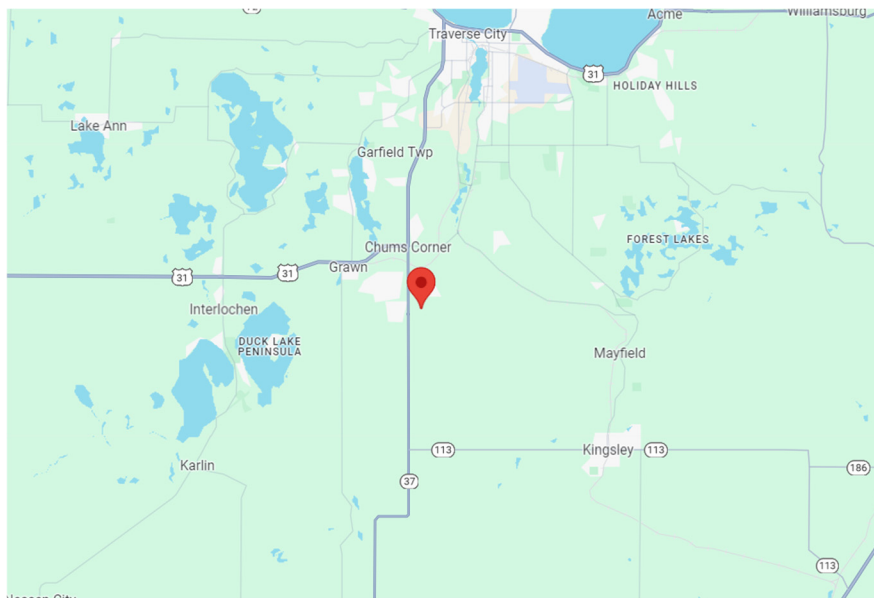

A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.
