Miscellaneous Breeds

There will be Puppy, Bred By Exhibitor, & Open Classes for each of the Miscellaneous Breeds in each sex.

Puppy and Bred-By classes will be divided by age if all-breed classes are divided.

Winners from these classes will compete for Best of Breed and Best of Opposite Sex to Best of Breed in each breed. Each Miscellaneous Best of Breed winner shall be eligible to compete for Best in Miscellaneous Class. All entries for Best in Miscellaneous Class shall be made after judging of the individual Miscellaneous breed classes. In the event that the owner of a dog designated Best of Breed shall not exhibit the dog in the Best of Miscellaneous Class Competition, no other dog of the same breed shall be allowed to compete. There shall be no further competition for dogs entered in the Miscellaneous Class. Ribbons shall conform to Chapter 5, Section 2 of AKC Rules.

4-6 Month Beginner Puppy Competition

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Section 2 - Entry and Eligibility

- Entry and eligibility requirements include:
- The Four-to-Six Month Puppy event may be offered at licensed, or member dog shows or conformation B matches at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the
 event including the same day as the event and must be listed in the premium list, entry form
 and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional
 handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month
 (Beginner Puppy) Competition. "Exhibition Only" entries are not eligible to earn awards in this
 competition.
- Dogs that are owned or co-owned by a professional handler, members of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers ' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.
- Exhibition Only entries may not be changed to be eligible to compete for awards after the close of entries.

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

ATTENTION EXHIBITORS

The Show Site will be available to exhibitors at noon on Friday. <u>No exhibitors may set up grooming equipment prior to noon.</u> Dogs and all equipment must be removed from the show site immediately following Best in Show judging Sunday.

PARKING

Exhibitor and visitor parking will be located on blacktop parking lots in front of Purina Event Center. Vehicles are limited to **ONE PARKING SPACE**. No ex-pens or crates allowed on blacktop, but are allowed on grass areas. No cones allowed in parking areas. **NO PARKING IN ROADWAYS** or next to building. St. Charles (MO) Kennel Club, Inc. parking committee will be in charge of all parking for this event.

RV PARKING

There are seventy-six RV parking spaces located behind the Purina Event Center, with 50 and 30 amp electric, sewer and water hookup (water may not be available in winter months). Once all of the RV parking spaces behind the Purina Event Center are full, then the Overflow lot would be used. Reservations should be made direct with Purina, see Rules and RV Parking Application on Page 21-22.

GROOMING & CRATING

Grooming and crating in designated areas only. Grooming in the Purina Event Center will be 5 x 10 foot spaces. The fee for grooming with electricity is \$30.00 for the entire event (see grooming space application on page 20). There will be a limited number of reserved grooming spaces with no electric at a fee of \$15.00 for the entire event, with a limit of one (1) space per person, until all spaces are sold. Spaces with electric and spaces without electric cannot be combined. Reservations will be accepted until Friday, January 9, 2026 at 6:00 pm. There will be limited free grooming spaces available with no electric, with a limit of one (1) space per person, NO SAVING OF SPACE IS ALLOWED. THERE WILL BE NO ELECTRIC CORDS ALLOWED IN FREE GROOMING AREA. Anyone found with dryers or electric cords in free grooming will face an event committee hearing & will be removed from the building. The free grooming area will be clearly marked. Exhibitors in free grooming are required to stack crates & limit the number of grooming tables to maximize space. Any crates in Great Hall MUST have a covering underneath them, whether it is a towel, rug, plastic, etc to help protect floor from damage. All Grooming Tables must have rubber or plastic caps on the end of legs. All Grooming Exhibitors are responsible for keeping their grooming areas as clean as possible each day & cleaning up all hair in your space before leaving the site. Crates placed ringside for showing MUST be removed immediately after the showing of your dog, they may not be left overnight.

The Purina Event Center will be available at 12:00 pm on Friday. Do not arrive before 12:00 noon. Bathing of dogs is restricted to bathing area of the building - no dogs allowed in restrooms. The Purina Event Center will close & doors will be locked at 10:00 pm & will re-open at 6:00 am. Guards will be on duty. Dogs may be left inside the building on Friday & Saturday nights only. In accordance with AKC policy, each dog that is left in the facility overnight must be identified with a tag stating the owner/agent's name and where they can be reached in case of an emergency. In the event of multiple entries, one tag will be sufficient provided it clearly outlines the number of dogs & the area in which they are crated. No cones, baby strollers, ex-pens, cocker pens or puppy pens allowed inside the building at any time. Please stack your crates and limit the number of grooming tables. All vehicles must leave their headlights on while loading & unloading in the designated loading/unloading areas which are clearly marked. No vehicles may park in roadways to unload.

EXHIBITORS & GUESTS

No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance". These are separate divisions of Purina and are not part of the show grounds. No dogs are allowed on the second floor of the Purina Event Center. No baby strollers, private golf carts, firearms or cones allowed on Purina Property or inside Purina Event Center.

All trophies must be claimed the day of the show - None will be mailed.







- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.

- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.
