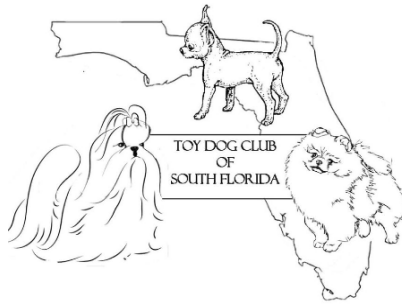

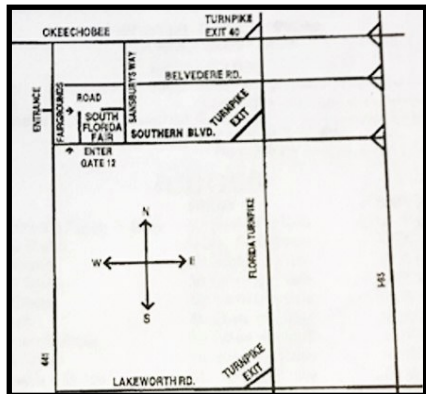

### Best of Breed (Variety) Competition

*The above classifications are provided for all breeds (and varieties). Additional divisions, (i.e. age, color, or weight) are in the breed list and must be indicated on the entry.*

## Non-Regular Classes Involving Single Dog Entries

The following classes will be provided for both dogs and bitches

**Veterans Class: 7 years of age and older.** \*Chapter 11, Section 8 "Rules Applying To Dog Shows" provide that a neutered male or a spayed bitch may be entered as a veteran. Winners from these classes are eligible, if undefeated in another class, for Best of Breed competition.

### Best Puppy

During the course of Regular judging, the assigned judge will select a Best Puppy from the Class winners of the 6 mos and under 9 mos and the 9 mos and under 12 mos. classes. This will be done after the Best of Breed Competition judging unless the Best Puppy award is automatic. **Example:** an entry from the Puppy Classes is awarded Best of Winners or Best of Breed. Only dogs undefeated in a Puppy Class are eligible for Best Puppy Competition. If the first place winner is not present, the second place winner may not compete.

### Best Bred-By-Exhibitor

During the course of Regular judging, the assigned judge will select a Best Bred-by-Exhibitor from the Bred-By-Exhibitor Class winners. This will be done after the Best of breed Competition judging unless the Best Bred-By-Exhibitor award is automatic. **Example:** an entry from the Bred-By-Exhibitor Class is awarded Best of Winners or Best of Breed. Only dogs and bitches undefeated in a Bred-By-Exhibitor Class are eligible for the Best Bred-By-Exhibitor Competition. If the first place winner is not present, the second place winner may not compete.

### Best Veteran

During the course of Regular judging, the assigned judge will select a Best Veteran from the winners of the Veteran Classes. This will be done after the Best of Breed competition judging unless the Best Veteran award is automatic. **Example:** an entry from the Veteran Class is awarded Best of Breed. Only dogs undefeated in a Veteran Class are eligible for Best Veteran Competition. If the first-place winner is not present, the second-place winner may not compete.

There shall be no further competition for dogs entered in the Miscellaneous Class. Ribbons shall conform to Chapter 5, Section 2 of AKC Rules.

### No Faxed Entries Accepted

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for the first entry and \$3.50 for each additional entry at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for each entry in Rally (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

**No Refund for Duplicate Entries.** Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
