NOTICE TO EXHIBITORS

- This show will follow COVID 19 Greene County, MO Guidelines.
- The Show Chairman has the right to make changes to the rules and guidelines as needed for safety.
- The grounds will be available to exhibitors, assistants, etc. from Friday 2:00 pm to Sunday immediately following Best in Show.
- No force or stand dryers permitted near ringside.
- Outside grooming and vehicle side grooming is permitted. Please bring shade, ie. pop up tent.
- Bring your own chair for Ringside seating and it must be removed as soon as you are finished. Any chairs left unattended will be subject to removal.
- Ringside crating will be available 15 minutes before and after your breed being judged. Please be mindful of other exhibitors and please adhere to the 15 minute rule.
- Please stack crates for small and medium sized dogs. No blocking of Vendor Booths or Premium Grooming allowed. Crates will be moved if blocking occurs.
- Cooperation with all Club & Clubs Show Committees, Site Control, parking personnel and Security including following instructions and directions is required. The use of rude, abusive or foul language, arguing or objectionable behavior against club officials, Site Control, parking personnel and Security will be immediately subject to a Bench Show Hearing. THERE WILL BE NO EXCEPTIONS!
- No EXTENDED Flex Leads allowed in any building or in the outside ExPen area.
- Exhibitors: We ask when at all possible please leave strollers outside and do not bring them into the buildings.
- Loading/Unloading Zones have a time limit of 20 minutes. If vehicle is left more than 20 minutes of inactivity, vehicle will be towed at owners expense.

VETERAN DOG CLASS - A Class for Dogs seven (7) years or older.

VETERAN BITCH CLASS - A Class for Bitches seven (7) years or older.

The above classification is provided for all breeds (and varieties). Additional divisions, i.e. (age, color or weight) are in the breed list and must be indicated on the entry.

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs

Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs

Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or canceled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

4-6 Month Beginner Puppy Competition

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Section 2 – Entry and Eligibility

- Entry and eligibility requirements include:
- The Four-to-Six Month Puppy event may be offered at licensed, or member dog shows or conformation B matches at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the event including the same day as the event and must be listed in the premium list, entry form and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as “Exhibition Only” in the Four-to-Six Month (Beginner Puppy) Competition. “Exhibition Only” entries are not eligible to earn awards in this competition.
- Dogs that are owned or co-owned by a professional handler, members of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.
- Exhibition Only entries may not be changed to be eligible to compete for awards after the close of entries. 7/31/24

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
