## **Non-Regular (Additional) Classes Involving Single Dog Entries**

### **Veteran Dog/ Bitch Class:** A class for dogs and bitches six (6) years or older

*Note: Castrated Dogs and Spayed Bitches are eligible for Veteran Classes at independent specialties and by virtue of winning the class, may compete for Best of Breed.*

#### **GAIT**

**Gait Class** - Following Best of Breed, dogs entered in the Gait class will be judged by Pauric Hand. The winner of this competition will exemplify the best Irish Wolfhound gait as described in the Irish Wolfhound Standard of Excellence. Dogs in this class **MUST** be entered in another class at this show.

## **Non-Regular (Additional) Classes Involving Multiple Dog Entries**

### **Non-Regular Classes Involving Multiple Dog Entries**

**Note:** Non-Regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.

**Stud Dog Class and Brood Bitch Class:** Each entry is allowed two to four get. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get must be entered in a regular class to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get being exhibited, must wear armbands. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

**Brace Class:** Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs **MUST** be entered in another class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

**Team Class:** Same rules as Brace Class. Substitute "Four" for "Two" and "Team" for "Brace."

\*On each Brace or Team entry, identify the bracemate or teammates.

### **BEST OF BREED COMPETITION**

**Awards of Merit** - At the judge's discretion, up to three Awards of Merit may be awarded to dogs competing in the Best of Breed competition. Not eligible for Award of Merit are Best of Breed, Best Opposite Sex, Select Dog, Select Bitch, Best of Winners, Winners Dog & Winners Bitch.

There will be competition for Best Puppy and Best Bred by Exhibitor.

**MOVE-UP POLICY FOR THE SPECIALTY AND TRIALS** — The Club will permit a move-up to the next level class in accordance with AKC regulations. The request for a move-up must be made in writing and presented to the Show Secretary or Trial Secretary at least 30 minutes prior to the start of the specified event, show or trial. Move-up forms will be available at the Secretary's Table.

**PARADE OF VETERANS:** Dogs in this class may or may not be entered in a regular class at this show; however, all dogs must be 6 years or older on the day of the show. The Class will not be judged. Each entry will receive a medallion and a commemorative certificate.

PLEASE NOTE: Refund of entry fees for bitches entered in Obedience or Rally that come in season after the closing date of this show may be obtained provided that a veterinarian's certificate and a request in writing is received by the Superintendent no later than 30 minutes prior to the start of judging. Transfers will be allowed at each trial per AKC Regulations.

**Novice Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class** - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

**NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.**



# AKC® Code of Sportsmanship and Civility

Preface: The tradition of competitive purebred dog events predates 1884—the year the American Kennel Club (AKC®) was founded. Those involved in these sports share core values, including a strong commitment to sportsmanship and a welcoming, respectful culture that embraces the diverse community united by a love of dogs.

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.
- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.

An AKC Event Fee of \$4.50 will be required for each entry in an event. There is no Event Fee for Junior Showmanship, Sweepstakes, Brace/Team, Multi-Dog Classes, or Special Attractions. A \$3.00 Event Fee will be required for each entry in 4-6 Month Beginner Puppy and each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.
