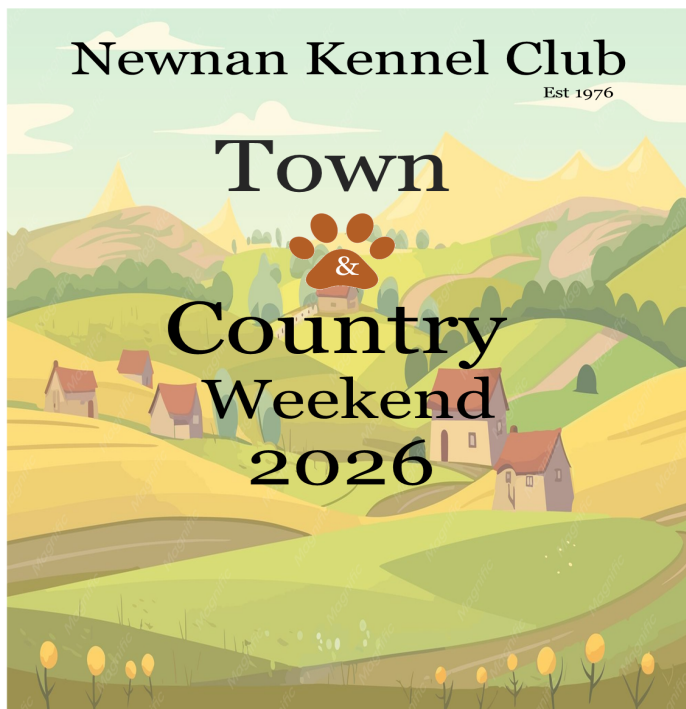

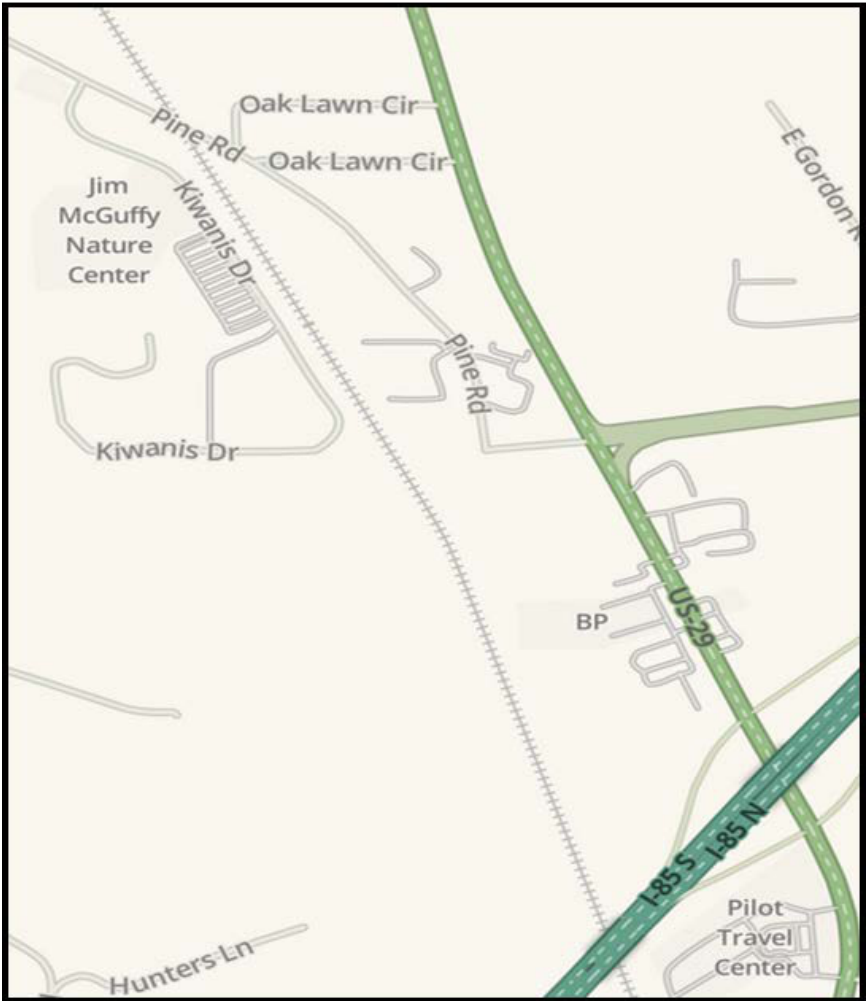

# GROOMING INFORMATION

- ⇒ Toy, Terrier, and Non-Sporting breeds will be judged indoors at the Ag Building, except for Dalmatians who will be judged out-of-doors. Stall areas are located adjacent to each side of the building with limited power. The stall surface has wood shavings. Stalls are separated by concrete walkways. **Exercise pens are allowed only in the stall area. Bring a rug to cover the shavings if your dogs require this. Do not set-up on the concrete walk-ways as this is prohibited by the fairgrounds.** Failure to follow this request will result in removal by the Show Committee.
- ⇒ All other breeds should plan to utilize the covered area near the outdoor rings. There is a 40x60 permanent cover for your use. **NO EXERCISE PENS ALLOWED UNDER THIS COVER.** All crates must be stacked. No saving of spaces. Limited power available. Please share
- ⇒ Overflow grooming on the grass is available next to the covered area. Pop-up tents and exercise pens are permitted. Several 20 amp plugs are available but may require 100 ft of electrical cord to utilize.
- ⇒ You may set-up for day-time grooming in any unoccupied spaces surrounding the midway including unused power plugs and water spigots.
- ⇒ **CLEAN-UP YOUR GROOMING AREA INCLUDING ALL TRASH AND HAIR.** This is not an option. Failure to do so could result in loss of this show-site!
- ⇒ **BATHING FACILITIES** with tubs are located in the Stall area of the Ag Building. Water spigots for your use are located throughout the fairgrounds.
- ⇒ **NO OVERNIGHT CRATING OF UNATTENDED DOGS ANYWHERE ON THE FAIRGROUNDS**

## TOWN AND COUNTRY WEEKEND RV PARKING INFORMATION

RV parking will begin at 9 a.m. on Thursday, October 15, 2026. There are a limited number of 30/50-amp spaces requiring 100 ft. of electrical cord and water hose. Half of these spaces are on a lower level from the show grounds requiring the use of a separate vehicle, i.e., golf cart or small car, or you can walk up to the show level by way of the stairs.

All 30/50-amp spaces will be filled by paid reservation on a first come basis. The remaining spaces have 20-amp service with payment required at the gate in CASH or by PAYPAL. A parking crew member will assist you to your space.

No space saving is allowed. No RV parking is allowed on paved areas. Any RV arriving after the parking crew leaves will be parked in the daytime parking area and can move inside the fenced show area the following day after BIS if requested and space is available. Any vehicle occupied overnight must pay for RV parking. All marked RV spaces are 25 ft. wide and set-ups must be within your space including any slide-outs. All units must be self-contained. No dumping is allowed and there is no dump station. Exhibitors are responsible for clean-up of their space.

### **ABSOLUTELY No overnight parking on Sunday**

**PRICES:** \$120/all 3 nights for 30/50-amp spaces. \$35/night for 20-amp or generating. There is an additional fee for use of PayPal.

## ATTENTION EXHIBITORS

The Show Site will be available to exhibitors on **Thursday, October 15, 2026 at 9:00 AM. NO ADMITTANCE PRIOR TO 9:00 AM.** Dogs must be removed from the Show Site immediately following Best in Show judging on Sunday, October 18, 2026.

In accordance with Chapter 1, Section 11 of the AKC Rules Applying to Dog Shows: **Only dogs that are eligible to be shown under The American Kennel Club rules shall be allowed within the show precincts**, except that dogs engaged as a special attraction with American Kennel Club approval may also be present. There shall be no benching, nor offering for sale or breeding, or any displaying of unentered dogs. These dogs shall be subject to all rules relating to health and veterinarians. The owners or agents shall be responsible for the care and safety of such dogs. Unentered dogs are not permitted within the official show site.

No exercise pens allowed in the outdoor covered grooming area. Crates must be stacked. No soft sided crates in grooming areas. No saving of spaces for other exhibitors. All crates must be clearly marked with the owners name and contact number in case of an emergency. The Show Committee reserves the right to remove any crates as necessary. **ABSOLUTELY NO OVERNIGHT CRATING IN THE GROOMING AREAS OR THE AG BUILDING.** See Page 10 for additional grooming information and restrictions.

### NO CRATING OF DOGS UNDER THE TENT

**FOR THE SAFETY OF EXHIBITORS AND DOGS, RINGSIDE CRATING IS PROHIBITED UNDER THE TENT. THE WALKWAYS AND OPEN AREAS UNDER THE TENT MUST BE KEPT CLEAR IN THE EVENT OF AN EMERGENCY.**

Any crates found under the tent will be removed by the Show Committee. Should your dog require shade, there is plenty of grassy area outside the tent to accommodate a pop-up tent or sunscreens over your crates. This will be strictly enforced. Crates may be left in the aisles outside of the tent.

### CRATING IN THE AG BUILDING

**RINGSIDE CRATING IN THE AG BUILDING IS PERMITTED DURING THE JUDGING OF YOUR BREED ONLY. CRATES MUST BE REMOVED FROM RINGSIDE IMMEDIATELY FOLLOWING THE JUDGING OF YOUR BREED.**

Any crates left ringside following the judging of your breed will be removed by the Show Committee. This will be strictly enforced. Crates may be left in the adjacent grooming areas of the Ag building.

**NO OVERNIGHT CRATING OF DOGS PERMITTED IN THE AG BUILDING OR ANY OF THE GROOMING AREAS. THIS INCLUDES THE GROOMING AREA ADJACENT TO THE AG BUILDING AND THE GROOMING AREA NEAR THE OUTDOOR RINGS. NO DOGS MAY BE LEFT UNATTENDED OVERNIGHT ANYWHERE ON THE SHOW GROUNDS.**

No bathing of dogs in restrooms. Exhibitors are responsible for cleaning up after their dogs everywhere on the show grounds, which includes the entire Fairgrounds. Bring your own chairs (none available). Food concessions will be available on the grounds.

**RV Parking:** Limited electrical hookups - Parking at direction of "RV Parking Crew" ONLY. *(Refer to RV parking form page 11 of the premium list)*. No personal shower facilities are available on site. No dumping of refuse tanks on the property. Get fuel before you arrive. The club will not provide fuel, cords or adapters. Potable Water is available onsite. Neither the Newnan Kennel Club, Inc nor the Coweta County Fairgrounds and Conference Center will be responsible for any RV fires, stolen items or mechanical repairs or RV repairs being made on the show grounds. Absolutely no overnight parking in paved parking area adjacent to Ag Building

**Novice Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class** - will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

#### Section 1 - Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

#### Section 2 - Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy (Beginner Puppy) Competition may be offered at licensed, or member dog shows or conformation B matches at the option of the show giving club.
- AKC licensed and member clubs sanctioned to hold all-breed conformation dog shows may offer a Four-to-Six Month (Beginner Puppy) Competition with any AKC sanctioned companion or performance event. When held with a companion or performance event, classes must be offered for all registrable breeds and varieties and for any breed eligible for entry in the Miscellaneous class and all FSS recordable breeds.
- Four-to-Six Month (Beginner Puppy) Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the event including the same day as the event and must be listed in the premium list, entry form and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. "Exhibition Only" entries are not eligible to earn awards in this competition.
- Dogs that are owned or co-owned by a professional handler, members of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.
- A change to modify an entry to Exhibition Only or from Exhibition Only to be eligible to compete for awards may not be made after closing.

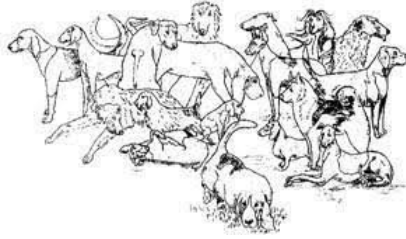

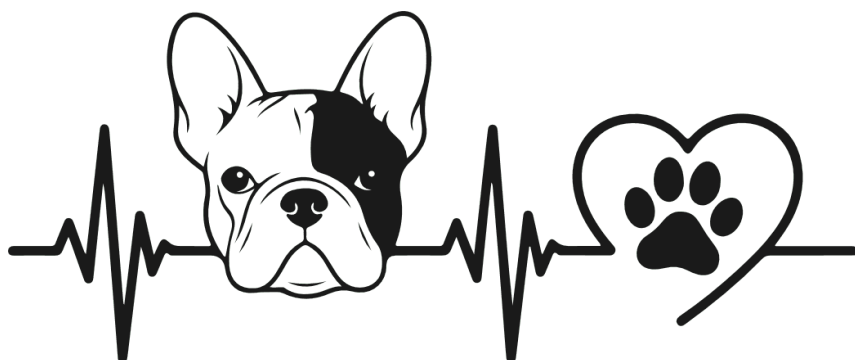

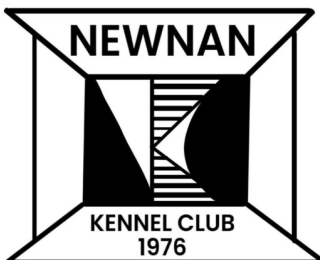

**Best Bred by Exhibitor Competition:** The judge will select a Best Bred-by-Exhibitor from the Bred -by-Exhibitor Class winners. This will be done after the Best of Breed Competition, unless the Best Bred-by-Exhibitor award is automatic. **Example:** An entry from the Bred-by-Exhibitor class is awarded Best of Winners or Best of Breed. Best Bred-by-Exhibitor will be selected from the First Place Winners of the Dog and Bitch in the Bred-by-Exhibitor classes, both Puppy and Adult. Only dog and bitches undefeated in a Bred-by-Exhibitor class are eligible for Best Bred-by-Exhibitor competition. If the first place winner is not present, the second place winner may not compete.

**Best Puppy Competition:** The judge will select a Best Puppy from the Regular Puppy Class (6-9 months, 9-12 months) and Bred-by-Exhibitor Puppy Class winners.
