## Best of Breed (Variety) Competition

### Non-Regular Classes Involving Single Dog Entries

*Winners from these classes are eligible, if undefeated in another class, for Best of Breed competition*

The following non-regular classes will be provided for both dogs and bitches

Entries in the Veteran and Coursing classes need not be intact.

**Veteran 7-10 Years Class** - 7 Years and Under 10 Years on the day of the show

**Veteran 10-12 Years Class** - 10 Years and Under 12 Years on the day of the show

**Veteran 12 Years & Over Class** - 12 Years and Older on the day of the show

**Coursing Class** - For dogs and bitches that are AKC registered and are confirmed lure coursing champions or open field coursing champions. Titles may be from any recognized coursing organization. NOTE:

Exhibitor must supply proof of eligibility for the class with entry. A copy of the certificate awarding the title or a copy of View Points/Summary of the Title Progression for this dog can be printed out and is an acceptable form of confirmation of title. Dogs & Bitches will not be entered into this class without proof of title accompanying the entry form. First place winners are eligible for Best of Breed competition provided all AKC eligibility and requirements have been met. If entering online, confirmation of title can be emailed to dogshows@barayevents.com, with registration number clearly indicated.

### Non-Regular Classes Involving Multiple Dog Entries

**Stud Dog/Brood Bitch Class** – Each entry is allowed two to four get. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get must be entered in a regular class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get being exhibited, must wear armbands. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

\*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Stud Dog in the Stud Dog Class and a spayed Bitch may be entered as a Brood Bitch in the Brood Bitch Class.

**Brace Class** (Two dogs of the same breed, one or more common owner) – **Each dog in the brace must be entered separately.** The dogs comprising a Brace must be named at the time the entry is made. If a dog which is to be part of the Brace is not entered in another class, it must be entered for "Brace Class Only" . In making entries for "Brace Class Only," full particulars must be given for each dog using the individual, regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for "Additional Class." If more than one Brace is entered by the same owner, the dogs comprising each Brace must be designated "Brace No. 1," "Brace No. 2."

*As the judge's decision in the Stud Dog, Brood Bitch, and Brace classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won any of these classes.*

**Best of Breed Competition:** The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

**Points for Reserve:** At the National Specialty, the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major in the region in which the event is held.

**Select Dog, Select Bitch, Award of Merit:** Select Dog and Select Bitch are recognized as the top quality of their sex after BOB and BOS have been awarded. As an Award of Merit is a club award and the Select is an official award of the AKC, the Select is of GREATER precedence than the Award of Merit. Awards of Merit are for those Salukis considered for Best of Breed or Best of Opposite Sex, and are chosen after the Select Dog and Select Bitch. Winners Dog or Winners Bitch are eligible, along with all other Salukis which, in the opinion of the judge, would, on another day, achieve Best of Breed or Best Opposite Sex to Best of Breed. SCOA offers a maximum of ten Awards of Merit, of which the Judge may award all, some, or none.

### Special Attractions

**Best from the Bred-by-Exhibitor Classes:** After Best of Breed, Selects, and Awards of Merit are chosen, the winners of Bred-by-Exhibitor Dog and Bred-by-Exhibitor Bitch, (Puppy and Adult) compete for Best Bred-by-Exhibitor. If Best of Winners is from any Bred-by-Exhibitor class, that entry is automatically Best Bred-by-Exhibitor.

**Best Puppy from the Regular Puppy Classes:** After Best of Breed, Selects, and Awards of Merit are chosen, the winners of Puppy Dog 6-9 months, Puppy Dog 9-12 months, Puppy Bitch 6-9 months, and Puppy Bitch 9-12 months, Bred-by-Exhibitor Puppy Dog 6-12 months and Bred-by-Exhibitor Puppy Bitch 6-12 months compete for Best Puppy. If the entry has been defeated by another puppy (Winners or Reserve), the entry is not eligible to compete for Best Puppy. If Best of Winners is from either the 6-9 month, 9-12 month or Bred-by-Exhibitor Puppy 6-12 month Class, that entry is automatically Best Puppy.

**Best Veteran from the Veteran Dog and Bitch classes:** After Best of Breed, Selects, and Awards of Merit are chosen, the winners of the Veteran Classes compete for Best Veteran. If Best of Breed is from a veteran class, that entry is automatically Best Veteran.

## **Master Class**

**Novice Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class** - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**SHOW LOCATION IS AVAILABLE TO EXHIBITORS AFTER 1:00PM, TUESDAY, JUNE 2, 2026**

- All crates and x-pens must be kept in the Grooming/Set-Up area on the plastic floor covering. Exceptions are for the Vendor Area and for designated day-crating area but all enclosures must have protection for the floor. We ask that all exhibitors strive to keep their dogs as quiet as possible. Thank you.
- Parking is allowed on blacktop surfaces only. **NO PARKING ON THE GRASS AREAS.**
- Vending is not allowed outside of the vending area, in vehicles, personal tents, or setups. Anyone vending will be required to pay the official vending fee. As a General Rule, Purina does not allow vending of any product that competes with Purina products.
- Please turn off cell phones and/or pagers before entering rings. Show Chairperson, Obedience & Rally Chairperson, and Assistant Show Chairpersons have the right to limit cell phone usage within 20 feet of the rings.
- The Show Site is Handicapped Accessible and there is parking in the front of the building.
- Exhibitors should follow their veterinarian's recommendation to ensure their dogs are free of internal and external parasites, free of any communicable diseases, and have appropriate vaccinations.
- At the discretion of the judge or show committee, in the case of inclement and/or dangerous weather conditions, judging may be moved into other suitable cover for the safety of the dogs, exhibitors, and other participants. This also applies to dangerous night-time weather when occupants of RVs may be asked to move indoors for their own safety.
- **CONSULT JUDGING PROGRAM FOR TIMES OF JUDGING.**

- **THE SHOW-GIVING CLUB, Show Secretary, and the Superintendent** have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
- **THE SHOW COMMITTEE/SECRETARY** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show as well as family, guests, and visitors in attendance.
- **CANINE COURTESY.** All dogs shall be kept under control at all times. You are responsible for picking up after the animals in your care. You may want to consider crate or X-Pen covers for the comfort of your dog. The building can be quite noisy.
- **PLEASE EXERCISE DOGS IN DESIGNATED AREAS ONLY.** There will be exercise areas and containers placed around the grounds. **PLEASE USE THEM.** All regulations will be enforced by Purina or the Show Committee.
- **NO GASOLINE OR DIESEL GENERATORS** are permitted within 50 feet of any building in which this dog show is being conducted, unless put there for the sole purpose of club use.

**PEE WEE CLASS SPECIAL ATTRACTION**

**Friday, JUNE 5, 2026 – NO ENTRY FEE**

**Judge: Mark Kocab**

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5–9 years of age. Safety is a primary concern.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class. • Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

REGISTRATION WILL BE TAKEN AT THE SHOW SECRETARY'S TABLE WEDNESDAY STARTING AT 9:00 AM. EACH ENTRANT WILL BE REQUIRED TO FILL OUT AN ENTRY FORM. IN ADDITION TO AN ENTRY, A RELEASE MUST BE SIGNED BY THE CHILD'S PARENT OR LEGAL GUARDIAN. JUDGING WILL BE HELD DURING THE LUNCH BREAK. NO ENTRY FEE.

## GROOMING/CRATING RESERVATIONS – 2026 NATIONAL SALUKI SPECIALTY

- Grooming/Crating spaces will be allowed in designated areas only, due to the use of special flooring in the Great Hall.
  - Reservations are for all days of the National and no partial reservations will be considered. The Grooming/Crating space reservation fee is \$50.00 per reserved space. No refund requests will be considered.
  - Because of limited space, please reserve only the number of spaces that you need and no more than two (2) spaces per exhibitor will be allowed. Requests for adjacent spaces must be received together.
  - Regular building hours are 6:00AM to 6:00PM or 30 minutes after the completion of judging, unless otherwise advised by the Show committee. **AFTER HOURS (OVERNIGHT) USE OF GROOMING/CRATING SPACES BY INDIVIDUALS OR DOGS IS STRICTLY PROHIBITED.** Violation of this rule will be met with a Purina Security response.
  - Exhibitors are responsible for cleaning up after their dogs. Failure to keep a grooming/crating space neat and in order could result in forfeiture of the grooming/crating space without refund. The SCOA Grooming Committee will monitor grooming/crating space and cleanliness.
  - A dog washing area is provided in the facility and also in the Service Center.
  - 10 – 20 amps electrical service will be available to each grooming/crating space.
  - Equipment must not be capable of damaging the flooring material in the Great Hall. Thick plastic will be in place in the grooming/crating area. This is to protect the floor.
  - The SCOA Grooming Committee reserves the right to limit and/or rearrange grooming/crating spaces if crowded conditions become a problem. The SCOA Grooming Committee reserves the right to remove equipment or crates left in undesignated areas.
  - Your reserved grooming/crating space will be determined by the SCOA Grooming Committee. The space will be clearly marked with your name and the space location will be posted at the entrances to the Event Center.
  - A very limited number of free spaces will be available after 1:30PM on Tuesday, June 2, 2026. Only one free space per exhibitor will be allowed and you may NOT save a free space for anyone else. Access to paid/ reserved grooming/crating spaces will be after 1:00PM on Tuesday, June 2, 2026. Each free space will be open to multiple exhibitors, as needed, and can only be assigned by SCOA Grooming Committee.
  - Once a space has been assigned, you may keep it until the end of the show or until you no longer need the space. You can leave your crates, chairs or other belongings in the Grooming/Crating area until the show is complete.
- Grooming/Crating space reservations will be accepted until May 20, 2026 or until all of the spaces are reserved. No more than two (2) spaces can be assigned to any exhibitor.**

# AKC® Code of Sportsmanship and Civility

Preface: The tradition of competitive purebred dog events predates 1884—the year the American Kennel Club (AKC®) was founded. Those involved in these sports share core values, including a strong commitment to sportsmanship and a welcoming, respectful culture that embraces the diverse community united by a love of dogs.

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.
- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.

## Notice to Exhibitors

**Telephone Entries and Unsigned Entries Cannot Be Accepted. Entries Not On Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.**

**Mail All Entries With Fees to Foy Trent Dog Shows, PO Box C, Sturgeon, MO. 65284.**

**Entries received without fees will not be accepted.** Acknowledgment of entries will be made as soon as practicable after closing via mail or email. **Should acknowledgment not be received by the exhibitor within a reasonable time. Please notify our office.**

### **No Faxed Entries Accepted**

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

An AKC Event Fee of \$4.50 will be required for each entry in an event. There is no Event Fee for Junior Showmanship, Sweepstakes, Brace/Team, Multi-Dog Classes, or Special Attractions. A \$3.00 Event Fee will be required for each entry in 4-6 Month Beginner Puppy and each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

**No Refund for Duplicate Entries.** Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

To find out about any AKC event cancellations, call the AKC Event Cancellation Hotline 877-252-3229.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor the Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging.

Judges need not wait for any dog holding up the class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

**The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.**

**PUBLICATION RIGHTS** By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

### INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
