

The following non-regular classes will be provided for both dogs and bitches

Entries in the Veteran classes need not be intact.

Veteran 7-9 Years Class - 7 Years and Under 9 Years on the day of the show

Veteran 9-11 Years Class - 9 Years and Under 11 Years on the day of the show

Veteran 11 Years & Over Class - 11 Years and Older on the day of the show

Field Class - For Dogs and Bitches who have an AKC Hunting or NAVHDA title. Entries in Field Class need not be intact.

Non-Regular Classes Involving Multiple Dog Entries (National Specialty Only)

Stud Dog Class – For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog must be entered in one of the Regular Classes or, if a Champion of Record, in Best of Breed competition, and must be entered in the Stud Dog class as an “Additional Class.” The Get must be entered in one of the Regular Classes or, if a Champion of Record, in Best of Breed competition.

The Stud Dog shall be considered one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the dog show rules, AKC policy, or the standard of the breed.

Brood Bitch Class - same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Stud Dog in the Stud Dog Class and a spayed Bitch may be entered as a Brood Bitch in the Brood Bitch Class.

Brace Class (Two dogs of the same breed, one or more common owner) – **Each dog in the brace must be entered separately.** The dogs comprising a Brace must be named at the time the entry is made. If a dog which is to be part of the Brace is not entered in another class, it must be entered for “Brace Class Only”. In making entries for “Brace Class Only,” full particulars must be given for each dog using the individual, regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for “Additional Class.” If more than one Brace is entered by the same owner, the dogs comprising each Brace must be designated “Brace No. 1,” “Brace No. 2.”

As the judge's decision in the Stud Dog, Brood Bitch, and Brace classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won either of these classes.

Points Available for Reserve

The Spinone Club of America will award at both the Parent and the National specialty a three point major to Reserve Winners Dog if the Regular Class Dog entry is twice the required number for a five point major in the division where the National Specialty is held.

Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

This event is designed to highlight and honor those Spinoni that fulfill their breed purpose as "hard working gun dogs" while remaining true to the structure and breed type of the Spinone.

ENTRY FEE: \$25.00 Entrants need not be entered in any other class at the SCOA National Specialty. All AKC registered dogs, including Champions of Record and spayed and/or neutered dogs/bitches are eligible for competition.

Regular and Veteran Class Qualifications:

Dogs/bitches who have earned an AKC JH, SH or MH title, or a NAVHDA qualifying prize score in NA, UPT, UT, or a VC title.

GUN DOG SWEEPSTAKES ELIGIBILITY

Gun Dog and Veteran Gun Dog Sweepstakes is open to any Spinone Italiano with an AKC Hunting title or NAVHDA Prize or Title. Gun Dog Sweepstakes is available to any Spinone Italiano 6 months and less than seven (7) years of age on the date of the event. Gun Dog Veteran Sweepstakes is available to any Spinone Italiano seven (7) years and older on the date of the event. Dogs/bitches may only be entered in one class and must be entered in the highest level class for which they are eligible. Dogs/bitches with both NAVHDA and AKC titles should be entered in the class that the owner believes to correspond with the most advanced title.

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5 to under 9 years of age at all shows offering Pee Wee.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- At an All-Breed event, all AKC fully recognized and Miscellaneous Class breeds are allowed to enter, including dogs with a PAL listing.
- In addition to an entry, a release must be signed by the child's parent or legal guardian. Release forms will be available at the show.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience—no Junior will be "judged" but rather will be mentored with the age appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation Rosette and each dog will receive a squeaky toy to commemorate the experience!

The Judge should explain the process of showing the dog to the Junior and the responsible adult in the ring including breed specific presentation. Depending on the size of the dog and the child, the adult may be asked to lift a table breed on or off the table, or the Club may mandate that the adult should do it regardless. Neither the youngster nor the adult should be asked to show the bite.

Entries close at the Superintendent's Office, Noon, June 8, 2022 or when the numerical limit is reached. On-site entries will be accepted on Friday and Saturday until 11:00 am at the Trophy Table or when the numerical limit is reached.
